**THE BOROUGH COUNCIL OF GATESHEAD (CHOWDENE / WHICKHAM
NORTH GATESHEAD) (SCHOOL KEEP CLEAR RESTRICTIONS)
TRAFFIC REGULATION ORDER 2016**

The Borough Council of Gateshead (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

PART I

Amendments to the Borough Council of Gateshead (No Stopping on School Entrance Markings) Order 2016

1. The Borough Council of Gateshead (No Stopping on School Entrance Markings) Order 2016 is amended as follows:
2. In Schedule 2 'No Stopping on School Entrance Markings', Item 22 (ii) and Item 22 (iii) relating to 'Front Street Community Primary School, Front Street, Whickham' are revoked in their entirety and replaced with the new Item 22 (ii) and (iii) below:-

22.	Front Street Community Primary School, Front Street, Whickham	(ii)	South side of North View from a point 21.5 metres east of its junction with Laburnum Grove in an easterly direction for 43.56 metres.
		(iii)	South side of North View from a point 109 metres west of Otterburn Gardens in a westerly direction for 43.56 metres.

3. In Schedule 2 'No Stopping on School Entrance Markings', after Item 74 relating to 'Haskel School, Bewick Road', insert the new Item 75 below:

75.	The Cedars School, Ivy Lane, Gateshead	(i)	South east side of Ivy Lane from a point 88.5 metres north east of Cedars Green in a north easterly direction for 43.56 metres.

4. In Schedule 3 'No Waiting At Any Time', after Item 31 relating to Athlone Place, Birtley', insert the following new Items below:

32.	Ivy Lane	(i)	North side from its junction with Durham Road in an easterly direction for 26 metres.
		(ii)	South side from its junction with Durham

			Road in an easterly direction for 13.5 metres.
		(iii)	North west side from its junction with Lyndhurst Grove in a south westerly direction for 7.5 metres.
		(iv)	South east side from a point 80.5 metres north east of Cedars Green in a north easterly direction for 8 metres.
33.	Lyndhurst Grove	(i)	North east side from its junction with Blackrow Lane in a north westerly direction for 7 metres.
		(ii)	South west side from its junction with Ivy Lane in a north westerly direction for 14 metres.
34.	Otterburn Gardens	(i)	Both sides from a point 60 metres south of its junction with Blake Avenue for the full extent of the turning head.
35.	School Street, Whickham	(i)	East side from its junction with Front Street in a northerly direction for 92.5 metres.
		(ii)	West side from its junction with Front Street in a northerly direction for 75 metres.

5. After Part VII relating to 'Disabled Person's Badge Parking Place Operating 24 hours on all days', insert the following new Part VIIA below:

"PART VIIA

No Waiting and No Loading operating from 8am to 5pm Monday to Friday (inclusive)

1. Save as provided in Part VIIA Article 2 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait, load or unload during the hours of 8am to 5pm Monday to Friday (Inclusive) in or on the lengths of road specified in Schedule 6 to this Order.

Exemptions

2. (1) Nothing in Part VIIA Article 1 to this Order, shall render it unlawful to cause or permit any vehicle to wait in the lengths of the road referred to therein for so long as may be necessary to enable:-

(a) the picking up or setting down of passengers;

(b) the vehicle, if it cannot be conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely-

(i) building or demolition;

- (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said roads;
 - (iv) the laying, erection, alteration or maintenance in or on land adjacent to the said length of road of any sewer, main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984;
- (c) any vehicle, if it cannot conveniently be used for such purpose in any other road, be used in pursuance of statutory powers or duties;
- (d) to enable a vehicle to be used by a postal operator in provision of a postal service;
- (e) any police, fire brigade or ambulance vehicle on emergency call or being used for such purposes;
- (f) any vehicle used in pursuance of statutory powers or duties;
- (g) any vehicle displaying a valid exemption certificate in the relevant position.”

6. After Schedule 5 relating to 'Disabled Person's Badge Parking Place Operating 24 Hours on All Days', insert the following new Schedule 6 below:

“SCHEDULE 6

**NO WAITING AND NO LOADING MONDAY TO FRIDAY (INCLUSIVE)
DURING THE HOURS OF 8AM TO 5PM**

1.	Blackrow Lane	(i)	Both sides from its junction with Ivy Lane / Lyndhurst Grove for its full length.
2.	Laburnum Grove	(i)	Both sides from its junction with North View in a southerly direction for 11 metres.
3.	North View	(i)	South side from a point 21.5 metres east of its junction with Laburnum Grove in a westerly direction for 47 metres.
		(ii)	South side from a point 79 metres west of Otterburn Gardens in a westerly direction for 30 metres.

PART II

Revocations

1. The Borough Council of Gateshead (School Street Whickham) (Waiting Restrictions) Traffic Order 2009 is hereby revoked in its entirety.

PART III

Savings and Commencement

1. (1) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.
(2) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
2. This Order shall come into operation on 12th day of August 2016 and may be cited as The Borough Council of Gateshead (Chowdene / Whickham North Gateshead) (School Keep Clear Restrictions) Traffic Regulation Order 2016.
