**THE BOROUGH COUNCIL OF GATESHEAD**  
**ASKEW ROAD AND SURROUNDING AREA (COVID-19 RESPONSE)**  
**EXPERIMENTAL TRAFFIC REGULATION ORDER 2020**

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1)to(3), 4(2), 9, 10, 32 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act'), and by virtue of the Traffic Management Act 2004 (hereinafter referred to as 'the 2004 Act'), and of all other enabling powers hereby make the following Order:-

**PART I**

**Citation and Interpretation**

1. This Order may be cited as "The Borough Council of Gateshead (Askew Road And Surrounding Area) Experimental Traffic Regulation Order 2020" and shall come into operation on 20<sup>th</sup> August 2020.
2. This Order shall remain in force for a period not exceeding 18 months.
3. This Order shall in accordance with Section 10(2) of the Act, enable the Council's Service Director for Development, Transport and Public Protection (or their duly authorised officer), to modify or suspend the operation of this Order or any provision of it, if it appears to them essential:
  - (a) in the interests of the expeditious, convenient and safe movement of traffic,
  - (b) in the interests of providing suitable and adequate on-street parking facilities, or
  - (c) for preserving or improving the amenities of the area through which any road traffic affected by the order runs.
4. The above power will only be exercised after consulting the Chief Officer of Police.

**PART II**

**Amendments**

**Amendments to The Borough Council of Gateshead (Traffic Movements) (Consolidation) Order 2010**

1. The Borough Council of Gateshead (Traffic Movements) (Consolidation) Order 2010 is amended for the duration of this Order as follows:

2. In Schedule 1.01 "Prohibition of Driving" suspend for the duration of this order:
  - a. Item 38 Half Moon Lane; and
  - b. Item 93 Unnamed Link Road between Half Moon Lane and Hills Street.
3. In Schedule 4.06 "No Entry to any Vehicle Except for Pedal Cycles" suspend for the duration of this Order item 3 Half Moon Lane/Mirk Lane.
4. In Schedule 4.03 "No Entry Except Buses" suspend for the duration of this Order Item 6 Wellington Street into Hills Street.
5. In Schedule 5.01 "No Right Turn" suspend for the duration of this Order;
  - a. Item 1 The southern section of the unnamed access road from Oakwellgate to the premises numbered 65 High Street Gateshead currently occupied by Auto Trader; and
  - b. Item 31 the westbound loop road linking the A167 (Tyne Bridge) southbound and Quaysgate – the Northern Section of the unnamed access road from Oakwellgate to the premises numbered 65 High Street Gateshead currently occupied by Auto Trader; and
  - c. Item 37 the northern section of the unnamed access road from Oakwellgate to the premises numbered 65 High Street Gateshead currently occupied by Auto Trader; and
  - d. Item 42 the part of the Gateshead Highway slip road to Eastgate (which bisects the roundabout located at the junction with High Street, Lambton Street and Eastgate – Gateshead Highway.
6. In Schedule 5.02 "No Left Turn for Pedal Cycles" suspend for the duration of this Order; Item 1 the northern section of the unnamed access road from Oakwellgate to the premises numbered 65 High Street Gateshead currently occupied by Auto-Trader – into the westbound loop and linking the A167 (Tyne Bridge) southbound and Quayside.
7. In Schedule 6.01 'Prohibition of Driving Except Pedal Cycles' insert the following new items in the appropriate place:

Item Number	Road Name, Description	Exemption
	Hills Street (i) North (a) for its entire length.	
	Quaysgate (i) South side (a) for its entire length.	
	Askew Road (i) South side (a) from its junction with West Street to its junction with High Street.	

	West Street (i) both sides (a) from its junction with Askew Road to the junction with Swinburne Street.

8. In Schedule 4.05 “No Entry to Any Vehicle” insert the following new items:

Item Number	Road Name, Description	Exemption
	Gateshead Highway to Quaysgate Link Road for its entire length.	
	Quaysgate, Northern Lane at its junction with Oakwellgate.	
	Nelson Street at its junction with the West Central Route.	

9. In Schedule 4.06 ‘no entry to any vehicles except for pedal cycles’ insert the following new item:

Street	Side	Description
Half Moon Lane	(i)Both	(a)From its junction with Wellington Street entering Hills Street in an easterly direction.

10. In Part II Prohibition of Driving, insert a new exception 1(21) as follows:

“(21) Any vehicle to proceed in the roads between the hours of 10:00am to 4:00pm and 6:00pm to 8:00pm for as long as may be necessary for loading and unloading purposes only.

11. In Schedule 1.01 ‘Prohibition of Driving’ insert the following new item:

Item number	Road name, description	Exemption
	Half Moon Lane, both sides from its junction with the north east kerb line of Mink Lane to its junction with Hills Street.	21

## **Amendments to The Borough Council of Gateshead (Bus Lanes) Traffic Regulation Order 2014**

12. In Schedule 7 "Bus Lane (Bus and Pedal Cycle Only)" suspend for the duration of this Order Item 2 West Central Route – the inside lane of the northbound carriageway from a point 9.5 metres north-east of the junction with Mulgrave Terrace in a north easterly then northern direction for 163.5 metres, then continuing in the central lane of that highway in a north westerly direction for 34 metres.

13. In Schedule 2 "Bus Lanes (Local Bus Only)" introduce the following items:

Item Number	Street, Side	Description
	Askew Road, North side (eastbound)	(a) From its junction with High Street in a westerly direction for a distance of 84 metres.
	Askew Road, North Side (eastbound)	(a) From a point 128 metres west of its junction with High Street in a westerly direction for a distance of 46 metres.
	West Central Route West side (northbound)	(a) In the northbound carriageway in the eastern lane from its junction with Askew Road to a point 238 metres south of Askew Road
	Quaysgate, North side	(a) For its entire length.

### **Part III**

#### **Savings and Commencement**

1. (i) The prohibitions and restrictions imposed by the Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.
- (ii) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under this Act, or

by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
