**THE BOROUGH COUNCIL OF GATESHEAD
(DUNSTON AND TEAMS AREA)
TRAFFIC REGULATION ORDER 2007**

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all the other powers then enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Part I
General**

Interpretation

- 1 In this Order the following expressions have the meanings hereby respectively assigned to them: -

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

"disabled person's parking disc" means a disc issued by a local authority (125 millimetres square) coloured blue if issued on or after 1st April 2000 or orange if issued before that date and is capable of showing the quarter hour period during which a period of waiting has begun: and -

"relevant position" means -

- (a) the disabled person's parking disc or disabled person's badge is exhibited on the dashboard of fascia of the vehicle; or
- (b) in the case of a vehicle not fitted with a dashboard or fascia, the disabled person's parking disc or disabled person's badge is exhibited in a conspicuous position on the vehicle;

so that the front of the disabled person's parking disc or disabled person's badge is clearly legible from the outside of the vehicle.

A vehicle displays a disabled person's parking disc or disabled person's badge in the relevant position if -

- (c) the disabled person's parking disc or disabled person's badge is exhibited on the dashboard of fascia of the vehicle; or
- (d) in the case of a vehicle not fitted with a dashboard or fascia, the disabled person's parking disc or disabled person's badge is exhibited in a conspicuous position on the vehicle

"universal service provider" has the same meaning as in the Postal Services Act 2000

Part II
Revocation and Amendment

2. (1) The Borough Council of Gateshead (Clockmill Road, Dunston (Prohibition of Driving) Order 1989 hereby revoked in full
- (2) The Borough Council of Gateshead (Colliery Road/St Omer's Road Area Dunston) (No Waiting At Any Time Restriction) Order 2003 is hereby revoked in full
- (3) The Tyne and Wear County Council (The Metropolitan Borough of Gateshead Traffic Regulation (Consolidation)) Order 1982 as amended, is hereby further amended by the: -
- i. the deletion of the description as set out in Item 24(i) of Schedule 25 to that Order and by way of replacement the revised description as set out in Schedule 1 to this Order should be read hereinafter as part of the said Order
 - ii. the deletion of Item 103 of Schedule 19 to the said Order
 - iii. the deletion of Item 24(ii) of Schedule 25 to the said Order

Part IV
Waiting Restrictions

Prohibition of Waiting at Any Time

3. Save as provided in Article 4 and 5 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait at any time in or on the length(s) of road(s) or sides of length(s) of road(s) specified in Schedule 2 to this Order.
4. (1) Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads referred to therein for so long as may be necessary to enable
- (a) the picking up and setting down of passengers;
 - (b) goods to be loaded onto or unloaded from the vehicle;
 - (c) the vehicle if it cannot conveniently be used for such purposes in any other road to be used in connection with any of the following operations, namely: -
 - (i) building or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance improvement or reconstruction of the said roads;

- (iv) the laying erection alteration or maintenance in or in land adjacent to the said lengths of roads of any sewer, main pipe or apparatus for the supply of gas water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (d) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority or water authority in pursuance of statutory duties;
 - (e) the vehicle to be used for the purpose of delivering or collecting postal packets in the service of a universal service provider
- (2) Nothing in Article 3 of this Order shall apply to any vehicle being used for Police, Fire Brigade or Ambulance purposes.
- (3) Nothing in Article 3 of this Order shall render it unlawful to cause or permit the following vehicles to wait: -
 - (a) a hackney carriage (as defined in the Town Police Clauses Act 1847) waiting at a duly authorised cab rank;
 - (b) a vehicle waiting on a parking place duly authorised by an Order made under the Act provided that the vehicle is parked in accordance with the provisions of such an Order.
- 5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a disabled person's parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in the lengths of road referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day).
- 6. This Order shall come into operation on 14 May 2007 and may be cited as the Borough Council of Gateshead (Dunston and Teams Area) Traffic Regulation Order 2007

SCHEDULE 1

Ellison Road Dunston - both sides from a point 41 metres east of its junction with Park Terrace in an easterly direction to its junction with Wilson Street

SCHEDULE 2
No Waiting At Any Time

1. **King Edward Avenue - Dunston** - i) east side from the junction with the Ellison Road in a southerly direction to the centre of its junction with Willow Avenue
ii) west side from the junction with the Ellison Road in a southerly direction to a point 7 metres south of the centre of its junction with Willow Avenue
2. **Team Street Dunston** - both sides from its junction with Rose Street to its junction with Clockmill Road
3. **Clockmill Road Dunston (A1114)** - both sides from its junction with Ellison Road to its junction with Festival Way
4. **Ellison Road Dunston** - i) north side from its junction with the Clockmill Road (A1114) to a point 34 metres north east of its junction with Wilson Street
ii) south side from its junction with the Clockmill Road (A1114) to a point 65 metres north east of its junction with Ravensworth Road
iii) south side from its junction with Ravensworth Road to a point 28 metres north east of its junction with Wilson Street
5. **Clockmill Road/ St Omers Road Dunston (A1114)** - both sides from its junction with Festival Way to the junction of St Omers Road and Handy Drive
6. **Askew Road West Teams** - both sides from its junction with the roundabout at the southern end of the Redheugh Bridge to its junction with Team Street/Rose Street.
7. **A1114 / Derwentwater Road** - both sides of the section of the A1114 and Derwentwater Road that extends from its junction with Clockmill Road to its junction with the A184 (Consett Route)
8. **Ropery Road Teams** - i) north side from its junction with Derwentwater Road in a north-westerly direction for a distance of 130 metres
ii) south side from its junction with Derwentwater Road in a north-westerly direction for a distance of 100 metres
