Experimental Traffic Regulation Order 2021**

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1)to(3), 4(2), 9, 10 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act'), and by virtue of the Traffic Management Act 2004 (hereinafter referred to as 'the 2004 Act'), and of all other enabling powers hereby make the following Order:-

PART I

Citation and Interpretation

1. This Order may be cited as "The Borough Council of Gateshead Galloway Road (Prohibition of Waiting) Experimental Traffic Order 2021" and shall come into operation on 5 July 2021.
2. This Order shall remain in force for a period not exceeding 6 months.
3. This Order shall in accordance with Section 10(2) of the Act, enable the Council's Service Director for Development, Transport and Public Protection (or their duly authorised officer), to modify or suspend the operation of this Order or any provision of it, if it appears to them essential:
 - (a) in the interests of the expeditious, convenient and safe movement of traffic,
 - (b) in the interests of providing suitable and adequate on-street parking facilities, or
 - (c) for preserving or improving the amenities of the area through which any road traffic affected by the order runs.
4. The above power will only be exercised after consulting the Chief Officer of Police.

PART II

Amendments

Amendments to The Borough Council of Gateshead (Galloway Road and Cowpath Gardens / Croxdale Terrace Back, Pelaw) (No Waiting at Any Time) Traffic Regulation Order 2015

1. The Borough Council of Gateshead (Galloway Road and Cowpath Gardens / Croxdale Terrace Back, Pelaw) (No Waiting At Any Time) Traffic Regulation Order 2015 is amended for the duration of this Order as follows:
2. In the Schedule revoke Items 1 and 2 for the duration of this Order.
3. In the Schedule insert the following new items for the duration of this Order:

Schedule

Item No	Road Name	Side	Description
1	Galloway Road	(i) North east	(a) From its junction with Shields Road from Heworth Roundabout to Victoria Road West to its junction with Lauder Way
2	Galloway Road	(i) South west	(a) From its junction with Shields Road from Heworth Roundabout to Victoria Road West in a south easterly direction for 94 metres, inclusive of junction radii
3	Lyons Court	(i) Both	(a) From its junction with Galloway Road in a south westerly direction for 10 metres
4	Cowpath Gardens/Croxdale Terrace Back	(i) East	(a) From its junction with Shields Road from Heworth Roundabout to Victoria Road West in a northerly direction for 29 metres

Part III

Savings and Commencement

1. (i) The prohibitions and restrictions imposed by the Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.
- (ii) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under this Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
