**THE BOROUGH COUNCIL OF GATESHEAD (GIBSIDE SCHOOL, SHIPCOTE LANE,  
GATESHEAD) (NO STOPPING ON SCHOOL ENTRANCE MARKINGS) TRAFFIC  
REGULATION ORDER 2021**

The Borough Council of Gateshead (hereinafter referred to as “the Council”) in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”), by virtue of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Northumbria Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

**PART I**

**Amendments to the Borough Council of Gateshead (No Stopping on School Entrance Markings) Traffic Regulation Order 2009**

1. The Borough Council of Gateshead (No Stopping on School Entrance Markings) Traffic Regulation Order 2009 is amended as follows:
2. Insert into Schedule 2 ‘No Stopping on School Entrance Markings’ the following new item listed below:

Item.	Street	Side	Description
	Shipcote Lane	(i) South	(a) From a point 24m east of the centre line of Avenue Road westwards for 37.56m.
		(ii) South	(b) From a point 61.56m east of the centre line of Avenue Road westwards for 37.56m.

**PART II**

**Savings and Commencement**

1. (1) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.  
  
(2) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
2. This Order shall come into operation on 22 day of October 2021 and may be cited as The Borough Council of Gateshead (Gibside School, Shipcote Lane, Gateshead) (No Stopping on School Entrance Markings) Traffic Regulation Order 2021.
