

**THE BOROUGH COUNCIL OF GATESHEAD
(FOLLINGSBY LANE, GATESHEAD)
(WAITING AND LOADING RESTRICTIONS)
TRAFFIC REGULATION ORDER 2022**

Notice is hereby given that on the 12 January 2022 the Borough Council of Gateshead (hereinafter referred to as “the Council”) made an Order in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) of The Road Traffic Regulation Act 1984 (“the 1984 Act”) and Part IV of Schedule 9 to the 1984 Act and by virtue of the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act.

The effect of the Order which will come into force on the 21 January 2022 will revoke Part II of The Borough Council of Gateshead (Follingsby Lane, Follingsby, Gateshead) (Waiting, Loading and Speed Restrictions) Traffic Regulation Order 2020 and introduce:

1. A prohibition of waiting at any time along the lengths of road set out in Schedule 1 below;
2. A prohibition of waiting and loading at any time along the lengths of road set out in Schedule 2 below;
3. A no right turn at Follingsby Lane into Follingsby Avenue;
4. A no left turn at Follingsby Avenue into Follingsby Lane

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act or that any requirement of the Act or of any instrument made under them has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply to the High Court for that purpose.

**SCHEDULE 1
Prohibition of Waiting at Any Time**

Follingsby Close – both sides from Follingsby Avenue in a westerly direction for approx. 60.5m.

Follingsby Avenue – west side - from a point 34.5m north of Follingsby Close centre line in a southerly direction for 100.5m including radii; west side - from a point 99m south of Follingsby Close centre line in a southerly direction for 40m; east side - from a point 90m south of its centre line with Shotton Way in a southerly direction for 84m including radii; south side - from a point 55.1m east

from its centre line with White Rose Way in an easterly direction for 42m including radii.

White Rose Way (running west to east) – south side - from its centre line with White Rose Way (running north to south from Follingsby Avenue) in an easterly direction for 52.8m including radii; **south side** - from a point 20m east of its centre line with White Rose Way (running north to south from Follingsby Lane) in a westerly direction for 85m including radii at junctions; **north side** - from a point 44m east of its centre line with White Rose Way (running north to south from Follingsby Lane) in a westerly direction for 169.1m including radii at junctions; **north side** - from a point 50.6m east of its centre line with White Rose Way (running north to south from Follingsby Lane) in an easterly direction for 34.7m including radii at junctions.

White Rose Way – (running south to north from Follingsby Lane – west side - from its junction with White Rose Way (running east to west) in a southerly direction for 27m including radii; **east side** - from its junction with White Rose Way (running east to west) in a southerly direction for 36.4m including radii.

SCHEDULE 2

Prohibition of Waiting and Loading At Any Time

White Rose Way – (running south to north from Follingsby Lane – both sides – from its junction with Follingsby Lane in a northerly direction for 14m.

Follingsby Lane – both sides - From a point 48.2m west of its centre line with White Rose Way in an easterly direction for 400m to the boundary with South Tyneside; **north side** – from a point 92.7m west of the centre line of White Rose Way in a westerly direction to the New Road / A194M roundabout including radii at junctions; **south side** – from a point 136.8m west of the centre line of White Rose Way in a westerly direction to the New Road / A194M roundabout including radii.

Follingsby Avenue – both sides – From its junction with Follingsby Lane in a northerly direction for 151m.
