

**THE BOROUGH COUNCIL OF GATESHEAD
(OFF STREET PARKING PLACES GATESHEAD)
(AMENDMENT NO. 1)(CONSOLIDATION)
TRAFFIC REGULATION ORDER 2022**

Notice is hereby given that on the 19 January 2022 the Borough Council of Gateshead (hereinafter referred to as "the Council") made an Order in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 19, 32, 33 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), by virtue of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Northumbria Police in accordance with Part III of Schedule 9 to the Act

The effect of the Order which will come into force on the 24 January 2022 will be to:

1. Amend the Borough Council of Gateshead (Off Street Parking Places Gateshead) Consolidation (Amendment No1) Order 2009 by:-
 - a. introducing interpretations for Electric Taxi and Electric Taxi Charging Bay;
 - b. revoke items relating to Mill Road Car Park and South Shore Road Car Park; and
 - c. revoke items relating to Pipewellgate Car Park and Garden Street Car Park and replace with new items as listed in the schedule below.
2. Amend the Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012 by:-
 - a. introducing interpretations for Electric Taxi and Electric Taxi Charging Bay.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act or that any requirement of the Act or of any instrument made under them has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply to the High Court for that purpose.
