TRAFFIC REGULATION ORDER 2022**

The Borough Council of Gateshead (hereinafter referred to as “the Council”) in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 19, 32, 33 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”), by virtue of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Northumbria Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

**PART I**

**Revocation and Amendments to The Borough Council of Gateshead (Off Street Parking Places Gateshead) Consolidation (Amendment No1) Order 2009**

1. The Borough Council of Gateshead (Off Street Parking Places Gateshead) Consolidation (Amendment No1) Order 2009 is amended as follows:
2. In Article 1 Part I INTERPRETATION, insert the following definitions:

**“Electric Taxi”** hackney carriage vehicle or private higher vehicle which uses electricity as source of power as a source of power.

**“Electric Taxi Charging Bay”** means a designated parking place within the car park that is only for the use of electric taxis when in the process of charging with electric.
3. In Schedule 4 ‘Charged Parking Places’ revoke the Items relating to ‘Mill Road Car Park & South Shore Car Park’ in their entirety
4. In Schedule 4 ‘Charged Parking Places’ revoke the Items relating to Pipewellgate Car Park and Garden Street Car Park and replace it with the new Items below

**PART II**

**Savings and Commencement**

1. (1) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.  
  
(2) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
2. This Order shall come into operation on 24 January 2022 and may be cited as The Borough Council of Gateshead (Off Street Parking Places Gateshead) (Amendment No.1) Traffic Regulation Order 2022.
