THE BOROUGH COUNCIL OF GATESHEAD (CROSS LANE, DUNSTON) EXPERIMENTAL TRAFFIC REGULATION ORDER 2022

The Borough Council of Gateshead (hereinafter referred to as the **Council**) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 9, 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the **1984 Act**) and by virtue of the Traffic Management Act 2004 (the **2004 Act**) and all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

Part I

Citation and Interpretation

- 1. This Order may be cited as "The Borough Council of Gateshead (Cross Lane, Dunston) Experimental Traffic Regulation Order 2022" and shall come into operation on 4th July 2022.
- 2. The Order shall remain in force for a period not exceeding 18 months.
- 3. The Order shall in accordance with Section 10(2) of the 1984 Act, enable the Council's Service Director Highways and Waste (or their duly authorised officer), to modify or suspend the operation of this Order or any provision of it, if it appears to them essential:
- 3.1 In the interests of the expeditious, convenient and safe movement of traffic;
- 3.2 In the interests of providing suitable and adequate on-street parking facilities; or
- 3.3 For preserving or improving the amenities of the area through which any road traffic affected by the order runs.
- 4. The above power will only be exercised after consulting the Chief Officer of Police.

Part II

Amendments
