**THE BOROUGH COUNCIL OF GATESHEAD  
(OFF STREET PARKING PLACES GATESHEAD)  
CONSOLIDATION (AMENDMENT NO1) ORDER 2009**

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and by virtue of the Traffic Management Act 2004, and of all other enabling powers in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order: -

**PART I**

**INTERPRETATION**

1. In this Order except where the context requires, the following expressions have the meaning hereby respectively assigned to them: -

**"the 1984 Act"** means Road Traffic Regulation Act 1984;

**"the 2004 Act"** the Traffic Management Act 2004;

**"authorised permit"** means a valid employee or councillor pass, seasonal permit or exemption permit being used in accordance with the conditions of use in respect of the relevant pass or permit;

**"civil enforcement officer"** means a person authorised by or on behalf of the Council under Section 76 of the Traffic Management Act 2004 to supervise and enforce the road traffic contraventions for which the Council is the enforcement authority.

**"the executive"** means the Tyne and Wear Passenger Transport Executive of Nexus House, 33 St James Boulevard, Newcastle upon Tyne NE1 4AX or any successor in title carrying out the same functions of the Executive;

**“executive vehicle”** means any authorised vehicle of the Executive that displays substantially on the main body of the vehicle the livery or formal markings representing the Executive as agreed with the Council;

**“penalty charge” and “reduced penalty charge”** means a charge set by the Council in accordance with the provisions of Section 77 and Schedule 9 of the Traffic Management Act 2004 and Regulations made thereunder and in accordance with any guidance given by the Secretary of State.

**“penalty charge notice” ‘PCN’** means a notice issued by a Civil Enforcement Officer pursuant to the provisions of Section 78 Traffic Management Act 2004 and Regulations made thereunder.

**“higher level contraventions”** are as defined in the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof.

**“lower level contraventions”** means all parking contraventions which are not higher level contraventions.

**“parking contravention”** has the same meaning assigned to it by Section 73 and Part 1 of Schedule 7 to the Traffic Management Act 2004.

**“parking charge”** means an amount set by Council payable at a ticket machine or ticket issuing machine in respect of a vehicle left in a parking place referred to in the Orders specified in Schedule 4.

**“coach”** means:

- (i) a motor vehicle constructed or adapted to carry more than 14 passengers (exclusive of the driver); and
- (ii) local buses not so constructed or adapted as defined in the Traffic Signs Regulations and General Directions 2002

**“the Council”** means the Borough Council of Gateshead acting by its Head of Transport and Highway Services or its duly authorised agent;

**“cycle bay or cycle space”** means any area of parking place as defined in this Article which is provided for the leaving of a pedal cycle or motor cycle and indicated by markings on the surface of the parking place or signed otherwise indicated by signs or any other structure whatsoever placed or erected in the parking place;

**“disabled person's badge”** has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 as amended by the Disabled Persons (Badges for Motor Vehicles) (England) (Amendment No 2) Regulations 2007;

**“disabled person's vehicle”** has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

**“driver”** in relation to a vehicle parked in a parking place means the person driving or riding the vehicle at the time it was left in the parking place;

**“employee pass” or “councillor pass” or “exemption permit”** means a pass/permit issued by the Council or any employee or agent authorised by the Council to issue such pass/permit on any such terms and conditions as it shall decide, permitting a driver to leave a vehicle in any parking place in accordance with the pass/permits terms and conditions of use without the purchase and display of a pay & display ticket;

**“hackney carriage”** has the meaning assigned to it by the Town Police Clauses Act 1847;

**“heavy vehicle”** means a vehicle (including any trailer that may be attached thereto) the unladen weight of which exceeds 3 metric tons;

**“motor car or light commercial vehicle”** means a mechanically propelled vehicle, the unladen weight of which does not exceed thirty hundred weight and which is less than six feet six inches in height and shall include a motor cycle but only when that motor cycle more than two wheels or has a sidecar attached which is either: -

- (i) constructed solely for the carriage of not more than twelve passengers and their effects exclusive of the driver; or
- (ii) constructed for the conveyance of goods or burden of any description

**“motor cycle”** includes a motor cycle provided that a motor cycle shall have no more than two wheels and no sidecar shall be attached thereto;

**“motor vehicle” or “vehicle”** means **“motor car or light commercial vehicle”** as defined in this Article and also any mechanically propelled vehicle intended or adapted for use on road, whether or not it is in a fit state for such use and includes any trailer intended or adapted for use as an attachment to such a vehicle, any chassis or body with or without wheels appearing to have formed part of such a vehicle or trailer and anything attached to such a vehicle or trailer;

**“owner”** has the same meaning as in Section 192(1) of the Road Traffic Act 1988;

**“parking apparatus” or “ticket machine”** means apparatus or a device of a type and design approved by the appropriate Secretary of State in accordance with Section 35(3) of the 1984 Act and which issues tickets indicating the time of the purchase of the ticket and the period in respect of which payment has been made;

**“parking bay”** means any area of a parking place which is provided for the leaving of a motor vehicle of a class specified and indicated by markings on the surface of the parking place or signed or otherwise indicated by signs or any other structure whatsoever placed or erected in the parking place as defined in this Article;

**“parking place”** means any area of land contained within the car parks defined within Schedule 2 to this Order and for the avoidance of doubt includes the private approach roads/access areas leading to any from any car park provided for use as a parking place;

- (i) by the Council under Section 32 of the 1984 Act for use as a parking place
- (ii) by any other person under Section 33(4) of the 1984 Act

**“pay and display ticket”** means a ticket issued in a car park by the parking apparatus;

**“payment period”** in relation to the parking places listed in Schedule 4 of this Order means the period specified in Column 4 on the days specified in Column 3 of the said Schedule;

**“permit holders bay”** means a parking bay within a parking place marked as a permit holders bay to be used only by vehicles displaying the appropriate valid seasonal permit;

**“pedal cycle”** means a unicycle, bicycle, tricycle, or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act;

**“permitted period”** means such period during the payment period that the driver of a vehicle has paid for in accordance with Article 37 of this Order;

**“private hire vehicle”** means a motor vehicle licensed by a local authority under section 48 of the Local Government (Miscellaneous Provisions) Act 1976 constructed or adapted to seat fewer than nine passengers other than a taxi or public service vehicle which is provided for hire with the services of a driver for the purposes of carrying passengers;

**“registered keeper”** means the person in whose name the vehicle was registered under the Vehicle Excise and Registration Act 1994;

**“relevant position”** means:-

- (i) in respect of a Disabled Person’s Badge or Disc,
  - (a) the badge is exhibited on the dashboard or fascia of the vehicle, or
  - (b) where the vehicle is not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle, and in each case so

that the date of expiry, the name of the issuing authority and the serial number are clearly visible and able to be read easily from outside the vehicle, and

(ii) in respect of pay and display ticket or authorised permit

- (a) in the case of a vehicle fitted with a front windscreen the pay and display ticket or authorised permit is exhibited therein on the nearside of and immediately behind the windscreen, or
- (b) in the case of a vehicle not fitted with a front windscreen the pay and display ticket or authorised permit is exhibited in a conspicuous position on the vehicle, and in each case so that the front face and all of the information including any expiry time and date, any date of validity and any reference number is able to be read from outside the vehicle;

**“seasonal permit”** means a permit purchased from the Council and issued subject to certain conditions, valid for the period and in the parking place specified on the permit;

**“specified payment for parking”** means the payment specified in respect of a parking place set out in Part II of Schedule 3 of this Order payable for parking in a parking place as displayed on or adjacent to the ticket machine relating to that parking place

- 2. (i) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (ii) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to the Article or Schedule bearing that number in this Order.
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if the purposes of that Act this Order were an Act of Parliament and the Orders revoked by Article 4 were Acts of Parliament thereby repealed.

## **PART II**

### **Revocation and Amendment**

1. (i) On the date on which this Order comes into operation the Orders specified in Schedule 1 to this Order ("the Orders") are hereby revoked.
- (ii) Proceedings under the Orders may be commenced in respect of any offence committed before the date on which this Order comes into operation against the provisions contained in them notwithstanding the fact that the Orders have been revoked.

## **PART III**

### **Use Of Parking Places**

#### **General**

1. Save as provided in Part III Article 3 the parking places specified in Schedule 2 to this Order may except where specified opening hours are displayed in a parking place be used at all hours on all days by all vehicles other than heavy vehicles.
2. Save as provided in Part III Article 3 the parking places specified in Schedule 2 to this Order may except where specified opening hours are displayed in a parking place be used at all hours by all vehicles other than heavy vehicles on the days specified in Column 2 of Schedule 4.
3. Nothing in Part III Articles 1, 2 and 14 shall render it unlawful to cause or permit a heavy vehicle to enter a parking place to this Order to enable such a vehicle, if it cannot conveniently be used for such purpose in any other place or road, to be used for access reasonably required with such a vehicle to premises or equipment in or adjacent to the parking place.
4. Save as provided in Part IV Article 1 where a sign or notice is displayed prescribing the maximum height limit for vehicles permitted to use a parking place no vehicle exceeding that height may use the parking place.
5. (i) A person shall not drive in a parking place a motor vehicle unless:-
  - (a) he or she is the holder of a licence authorising him or her to drive a motor vehicle of its class or description on a road, or

(b) he or she is the holder of a provisional driving licence and is accompanied in the vehicle by a person holding a licence of the type mentioned in (a) above.

(ii) The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle is licensed in pursuance of the provisions of the Vehicle Excise and Registration Act 1994 and unless there is in relation to the use of the vehicle by the driver such a policy of insurance.

6. A person shall not drive in a parking place a motor vehicle at a speed exceeding that officially notified by way of signs or in the absence of such signs at a speed exceeding ten miles per hour.

7. A driver of a vehicle using a parking place shall not park the vehicle in any position other than within a parking bay indicated as being reserved for vehicles and in particular, such a driver shall not park the vehicle on any space indicated by appropriate markings as being reserved for official use or to be kept clear and shall not park the vehicle in such a position as to impede the free access to and egress from the parking place.

8. (i) Any vehicle parked in a parking place shall park in as convenient a manner as possible and so as not to cause unnecessary obstruction.

(ii) No person shall cause or drive or park his vehicle so as to cause or be likely to cause damage to any parking place.

(iii) Where a parking place has been marked into parking bays the following provisions shall apply: -

(a) Any vehicle parked in such a parking place shall park wholly within a parking bay.

(b) No vehicle other than a disabled persons vehicle shall park or stop in any bay shown to be reserved for such vehicles.

(c) No vehicle other than a cycle or motor cycle shall park in a cycle parking space.

(d) No vehicle shall enter or park in any parking place or bay suspended in accordance with Part III Article 9 of this Order.

- (e) Subject to paragraph (i) of this Article and unless a part of a parking place is marked to be reserved for heavy vehicles paragraph (iii) (a) above shall not apply to heavy vehicles lawfully parked in a parking place.
  - (f) No vehicle other than a vehicle displaying a valid seasonal permit for that parking place shall park in a permit holders parking place or bay.
  - (g) The driver of any motor vehicle in a parking place shall comply with any instructions given, whether orally or by person duly authorised in that respect by the Council, by directions, signs or in any other manner as to the route to be followed within the parking place.
  - (h) Where in accordance with the provisions of this Order a parking place is described available for motor vehicles of specified classes, the driver of a vehicle shall not permit it to wait in that parking place unless it is of one of the specified classes
9. The Council may at any time and for any period close or suspend any parking place or any parking bays provided they give at least 7 days clear notice (except in the case of emergency) that the place or bay is closed or suspended.
  10. Except where Part VII Article 1 (ii) applies of this Order no vehicle shall be permitted to park in a parking place for a total length of time of more than twenty four continuous hours in any period of forty eight hours.
  11. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in a position in a parking place or bay and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
  12. Except with the written consent of the Council first having been received no person shall use any part of a parking place or cause or permit any vehicle to be left in a parking place: -
    - (i) for sleeping or camping purposes
    - (ii) for cooking purposes
    - (iii) for lighting or causing to be lit any fire

- (iv) for the purpose of repairing, servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place, except that the Council may authorise in writing any person or body to wash vehicles in any specified parking place
  - (v) for the selling or offering for sale of any goods or services or for the parking or storage of any hackney carriage or hire vehicle when such vehicle is not subject to a contract for hire.
13. Except with the written consent of the Council first having been received no person shall erect or cause or permit to be erected any tent, booth, stand, building or other structure in a parking place.
14. Save as provided in Part III Article 3 of this Order no person shall, except with the permission of the Council, drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.
15. Where a parking place is so marked or signed, no person shall drive or cause or permit to be driven any vehicle in a parking place so that it: -
- (i) enters the parking place otherwise than by an entrance or leaves the parking place other than by an exit so indicated;
  - (ii) drives in a direction other than that specified
16. The driver of a motor vehicle using a parking place shall not unnecessarily sound any horn or other similar instrument.
17. No person shall cause or take part in any gathering or demonstration within a parking place, or cause any unreasonable or unnecessary noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood.
18. No person shall in a parking place use any threatening, abusive or insulting language, gesture or conduct with intent to put any persons in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.

19. Any person who willfully or carelessly damages in any way or interferes with the fabric or structure or equipment of any parking place, shall be in contravention under this Order and in addition to the penalty charge payable, shall be liable for the cost of repair of the damage.
20. Except with the prior written consent of the Council, no person shall affix to the exterior of any vehicle or any part thereof in the parking place or to the fabric, structure or equipment of any parking place or any part thereof any advertisement of promotional literature.
21. No person shall do anything to interfere with the use and enjoyment of any parking place by other users of the parking place and in particular no person shall obstruct or misuse any of the ramps stairs doors or lifts in a parking place.
22. No person shall except with the permission of any person duly authorised by the Council drive any vehicle into a parking place where there is exhibited at the entrance to the parking place a notice indicating that the parking place is full or closed.
23. (i) The Council may provide occasional reserved parking space in accordance with paragraph (ii) of this Article.  
  
(ii) Upon application from a local authority or an organisation the Council may provide the facility for occasional reserved parking spaces in accordance with the terms and conditions previously agreed by the Council.
24. Any right of passage within any parking place is available only to persons driving or being conveyed in motor vehicles or riding or being conveyed on other vehicles and does not extend to pedestrians and no rights of way whatsoever over the said parking places other than for the purpose of parking vehicles shall be deemed to have been granted by the Council by virtue of this Order.
25. No person other than a person authorised by the Council, the driver of or a passenger in a vehicle parked or intended to be parked in a parking place, or other person authorised by such driver or passenger shall enter such parking place for any purpose whatsoever.
26. Notwithstanding the provisions of this Order the Council reserve the right to grant upon such terms and conditions as they think fit rights of access across any of the parking place to which this Order applies for the purpose of obtaining rear access to premises adjoining such parking places, in which case the provisions

of this Order shall apply to vehicles exercising such rights in accordance with the terms and conditions thereof.

27. (i) If in any case, owing to the presence of a motor vehicle in a parking place, an accident occurs whereby personal injury is caused to a person other than the driver of that vehicle or damage is caused to a vehicle other than that motor vehicle or to any other property whatsoever, the driver of the motor vehicle shall stop and, if required so to do by any officer, agent or servant of the Council or any other person having reasonable grounds for so requiring, give his name and address and also the name and address of the owner and the identification marks of the vehicle.
- (ii) If in the case of such accident as foresaid, the driver of the motor vehicle for any reason does not give his name and address to any such persons aforesaid, he shall report the accident at the nearest police station or to a police officer as soon as reasonably practicable and in any case within twenty-four hours of the occurrence thereof.

#### **PART IV** **Special Provisions**

1. The provisions of this Order shall not apply to any police vehicle not exceeding a weight of 3 metric tons designed specifically for the transport of horses on operational duty from parking or waiting in any parking place as specified in writing by the Council
2. **In respect of the Coach Car Park no person shall park or drive any vehicle other than a coach within that parking place**
3. In respect of the Felling Metro Car Park no person shall park any vehicle other than an executive vehicle authorised by the executive, in the dedicated bay for executive vehicles.

#### **PART V** **Charges**

1. (i) If a vehicle is left in a parking place in contravention of any of the provisions of this Order a penalty charge shall be payable

- (ii) If the penalty charge becomes payable in respect of any vehicle, a civil enforcement officer or the Council may issue a PCN in accordance with Section 78 of the 2004 Act
- 2.
- (i) Save as provided in Part V Articles 4, 5 and 6 the use during the payment period of a parking place specified in Schedule 4 to this Order on the days specified in Column 2 of the said Schedule shall be subject to the payment of the specified parking payment, such payment being the amount to be paid for parking for a given period as is specified in Column 5 of the said Schedule and is displayed on a notice board on or adjacent to the ticket machine or at the entrance to the parking place.
  - (ii) The driver of a vehicle shall on parking his vehicle in a parking place pay the specified parking payment by inserting an appropriate coin or coins in the parking apparatus situated at the entrance of or in the parking place and prominently display the ticket issued by the said apparatus in the relevant position so that the information conveyed thereon is clearly visible from the outside of the vehicle.
  - (iii) The driver of the vehicle shall attach any ticket issued on payment of the charge referred to in paragraph (i) of this Article in the relevant position on the vehicle in respect of which it was issued and shall ensure that the whole of the front of the ticket is clearly visible and that the ticket shall remain visible for the whole duration that the vehicle is parked in the parking place.
  - (iv) Once a ticket has been displayed in accordance with paragraph (iii) of this Article no further such ticket may be displayed in the vehicle unless it has returned to the parking place as provided for in Part V Article 3 of this Order.
  - (v) The driver of the vehicle shall ensure that a ticket is purchased and displayed as described in the preceding paragraphs to cover the entire period that the vehicle is parked within the parking place.
  - (vi) The driver shall remove the vehicle from the parking place at or before the end of the permitted period.
  - (vii) Any person who willfully avoids or seeks to avoid, or assists in avoiding, the payment of the appropriate charge at any parking place shall be guilty of a contravention under this Order.

3. Once a vehicle has been removed from a parking place it shall not be returned to the same parking place until a period of at least one hour has expired.
4. Nothing in Part V Article 2 of this Order shall apply to a disabled person's vehicle that displays in the relevant position a valid disabled person's badge.
5. A motor cycle or a pedal cycle may be parked free of charge in any parking place in which an applicable parking bay or space has been marked out provided the motor cycle or pedal cycle is parked wholly within the said space.
6. In the event of any parking apparatus, provided for under this Order, failing to function, a civil enforcement officer may collect any parking charge payable in respect of a vehicle, and issue a ticket, containing the details specified in respect of a ticket issued by a parking apparatus, to the driver of the vehicle.

## **PART VI**

### **Permits**

1. (i) Save as provided in Part VI Article 2 a seasonal permit may on application be purchased from the Council for such charges as may from time to time be determined by the Council, and that seasonal permit shall be valid in such parking place or places and on such days and at such times as is specified thereon during the period in respect of which it has been issued SUBJECT TO the Council reserving the absolute right to refuse the issue of seasonal or period tickets and FURTHER reserving the absolute right to withdraw and revoke any such seasonal permit which has been issued SUBJECT to reimbursement of any proportionate part of the fee relating to an unexpired period and the driver of any vehicle who is the rightful holder of a current seasonal permit parking that vehicle in a parking place for which the seasonal permit is valid shall exhibit that ticket on the vehicle in the manner prescribed by Part V Article 2 (iii). A seasonal permit shall remain visible for the whole duration that the vehicle is parked in the parking place.
- (ii) Save as provided in Part VI Article 2 the Council or any authorised agent of the Council may at its sole discretion issue a seasonal permit or exemption permit

2. No person other than an occupant of a business premises in the vicinity of the following parking places may apply to the Council for the issue of a seasonal permit in relation to that parking place within the vicinity of their business.

- (i) Back Regent Terrace/Walker Terrace Car Park
- (ii) Swinburne Street Car Park
- (iii) Town Hall Car Park

## **PART VII**

### **Removal of Vehicles**

1.
  - (i) When a vehicle is left in a parking place in contravention of any of the provisions of this Order, the Council may remove the vehicle or arrange for it to be removed from that parking place.
  - (ii) Where it appears to the Council that a vehicle left in a parking place has been abandoned the Council may remove the vehicle or arrange for it to be removed from that parking place provided that where it is proposed to move such a vehicle which in the Council's opinion is in such condition that it ought to be destroyed, then they shall not less than seven days before removing it cause to be affixed to the vehicle a notice stating that they propose to remove it for destruction at the end of that period.
  - (iii) In the case of emergency the Council or a civil enforcement officer may move or cause to be moved any vehicle parked in a parking place and may remove it if necessary from the parking place.
2. When moving or removing a vehicle by authority of Part VII Article 1 of this Order the Council or civil enforcement officer may do so by towing or driving the vehicle or in such other manner as they may think necessary to enable it to be moved or removed as aforesaid and shall make such arrangements as may be deemed necessary for the safe custody of the vehicle and the provisions of the Refuse Disposal (Amenity) Act 1978 shall apply to any vehicle removed in accordance with that Article except that where a vehicle is moved in accordance with Part VII Article 1 (iii) those provisions shall only apply for the purpose of tracing the registered keeper.

## **PART VIII**

### **Enforcement**

1. For the purposes of this Order the driver shall be assumed to be the registered keeper unless such person can satisfy the Council that he was not in fact driving the vehicle at the relevant time.
2. If the driver of a vehicle to which a PCN has been issued in accordance with the provisions of Part V Article 1 (ii) of this Order fails to pay the Penalty Charge, the Council may enforce the penalty charge in accordance with any regulations made under Section 82 of the 2004 Act.
3. This Order may be cited as the Borough Council of Gateshead (Off Street Parking Places Gateshead) (Consolidation Amendment No1) Order 2009 and shall come into operation on the 7 day of June 2009.





**Part I**
