TRAFFIC REGULATION (CONSOLIDATION)

ORDER 1982

EXPLANATORY NOTE

This note does not form part of the Order

1. This Order revokes the majority of the Traffic Regulation Orders made by Tyne and Wear County Council and Gateshead Metropolitan Borough Council up to the end of December 1981 (and also those Orders made by the former County Borough of Gateshead, County Council of Durham and Blaydon Urban District Council – the restrictions of which now lie within the new Gateshead boundaries) and reproduces their provisions in consolidated form without amendment.
2. For technical reasons the following Orders are not included in the consolidation and their provisions will remain in force unchanged:-
 - (a) Experimental and temporary Orders;
 - (b) Speed restriction Order;
 - (c) Residents parking places (with permits) Orders;
 - (d) On street parking places Orders;
 - (e) Off street parking places Orders;
 - (f) Stopping up Orders.
3. The Orders affected by this Consolidation are specified in Schedule 1 to this Order.
4. All distances specified in this Order are approximate distances.

TRAFFIC REGULATION (CONSOLIDATION) ORDER 1982

Tyne and Wear County Council in exercise of their powers under Section 1(1), (2), (3), (6) and 84D(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as “the Act of 1967”) and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84 C(1) of the said Act of 1967, hereby make the following Order:-

INTERPRETATION

1. In this Order:-

“stage carriage” means a public service vehicle being used in the operation of a local service (as defined in Section 3(2) of the Transport Act 1980);

“scheduled express carriage” means an express carriage as defined in Section 3 of the Transport Act 1980 which is not being used to provide an excursion or tour;

“school bus” means a vehicle constructed or adapted to carry 12 or more passengers and being used to carry persons to or from school as defined in Section 114(1) of the Education Act 1944;

“works bus” means a vehicle constructed or adapted to carry 12 or more passengers which has been provided by an employer for the purpose of carrying persons employed by him or on his behalf to or from their place of employment and being used for such a purpose;

“public service vehicle” means a motor vehicle as defined in Section 2 of the Transport Act 1980;

“disabled person’s badge” has the same meaning as the Disabled Persons (Badges for Motor Vehicles) Regulations 1975;

“disabled person’s vehicle” has the same meaning as in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England and Wales) (Amendment) Regulation 1975;

“disabled person’s parking disc” means a disc, issued by a Local Authority complying with the requirements of the British Standard Specification for Parking Discs (BS No. 4631 1970), but coloured orange and capable of showing the quarter hour period during which a period of waiting begins;

“relevant position” means:-

- (a) in the case of a vehicle fitted with a front windscreen the disabled person’s badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen:
or
- (b) in the case of a vehicle not fitted with a front windscreen the disabled person’s badge is exhibited in a conspicuous position on the front or near side of the vehicle;

“carriageway” means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have right of way for the passage of vehicular traffic;

“main carriageway” in relation to a road or carriageway means any carriageway of that road or any part of that carriageway constructed or adapted for the passage of vehicular traffic but excludes any lay-by;

“lay-by” means any area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in Diagram 1010 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981 and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed;

“verge” means any part of the road which is not a carriageway;

“heavy commercial vehicle” has the same meaning as in Section 104(1A) of the Road Traffic Regulation Act 1967;

“hackney carriage” has the same meaning as in Section 38(1) of the Vehicles (Excise) Act 1971;

“authorised cab rank” means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.1 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981;

“authorised parking place” means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1967;

“bus stop area “ means that length of carriageway referred to in Item 52 of Schedule 19 intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025.2 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981.

“prohibited area” means, in relation to Article 85, that area of a road which is comprised within and indicated by a road marking complying with either diagram 1025.1 or diagram 1025.3 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981.

PART 1 – REVOCATION PROVISIONS

2. The Orders specified in Part 1 of Schedule 1 to this Order and having effect by virtue of Section 110(2) of and paragraph 1 of Schedule 8 to the Road Traffic Regulation Act 1967 as amended aforesaid and the Orders specified in Part II of Schedule 1 to this Order are hereby revoked.

PART 2 – PROHIBITION OF DRIVING – ANY LICENCE

3. In this part –

“relevant traffic sign” means the sign shown in diagram 616 of Schedule 1 to the Traffic Signs Regulations and General Directions 1981.

4. Save as provided in Article 5 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to proceed past the points or in the lengths of roads specified in Part 1 of Schedule 2 of this Order.
5. Nothing in Article 4 of this Order shall apply to:-
 - (a) a pedal cycle, where so specified by reference to this Article in the said Schedule;
 - (b) any police, fire brigade or ambulance vehicle on emergency call, where so specified by reference to this Article in the said Schedule.
6. Save as provided in Article 7 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to proceed in the length of road specified in Part II of Schedule 2 to this Order.
7. Nothing in Article 6 of this Order shall apply to:-
 - (a) a stage carriage, scheduled express carriage, school bus or works bus;
 - (b) a vehicle, where so specified by reference to this Article in the said Part of the said Schedule being used in connection with:-
 - (i) any building or demolition operation,
 - (ii) the removal of any obstruction to traffic,
 - (iii) the maintenance, improvement or reconstruction of the road, or

- (iv) the laying, erection, alteration or maintenance in or near the roads or any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
 - (c) a vehicle being used in the service of a local authority or of a water authority in the pursuance of statutory powers or duties;
 - (d) a police, fire brigade or ambulance vehicle on emergency call;
- 8. No person shall cause or permit any vehicle to proceed on the road or length of road specified in Part III of Schedule 2 to this Order when the relevant sign is displayed.

PART 3 – PROHIBITION OF DRIVING – MOTOR VEHICLES

- 9. Save as provided in Article 10 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle to proceed in the lengths of road specified in Column 1 of Schedule 3 to this Order.
- 10. Nothing in Article 9 of this Order shall apply to any class or description of vehicle where so specified by reference to this Article in Column 2 of the said Schedule:-
 - (a) any police, fire brigade or ambulance vehicle on emergency call,
 - (b) any vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operation in or adjacent to the road or lengths of road, the removal of any obstruction to traffic, the maintenance, improvement or

- reconstruction of the road, or the laying, erection, alteration or maintenance in or near the land adjacent to the roads of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878,
- (c) any vehicle being used for the conveyance of persons, goods or merchandise to or from any premises situate on or adjacent to the roads or lengths of road,
 - (d) any vehicle being used for the purpose of agriculture in connection with land adjacent to that length of road or for the conveyance of timber felled upon that land,
 - (e) any stage carriage, scheduled express carriage, school bus or works bus,
 - (f) a vehicle being used in the service of a local authority or of a water authority in pursuance of statutory powers or duties,
 - (g) a vehicle being used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953,
 - (h) any mechanical road cleansing vehicle.

PART 4 – BUS LANES

11. In this part of this Order:-

“bus lane” means those parts of the carriageway of a road as described in Schedule 4 to this Order which are indicated by traffic signs consisting of carriageway markings of the types shown in diagram 1049 in Schedule 2 of the Traffic Signs Regulations and General Directions 1981;

“pedal cycle” means a pedal bicycle or pedal tricycle, not being in either case a motor vehicle.

12. Save as provided in Article 13 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle to proceed in a Bus Lane.
13. Nothing in Article 12 of this Order shall apply to any of the following:-
 - (a) a stage carriage, scheduled express carriage, school bus or works bus;
 - (b) any police, fire brigade or ambulance vehicles on emergency call;
 - (c) any vehicle being used for the removal of any obstruction to traffic in the Bus Lane;
 - (d) a mechanical road cleansing vehicle;
 - (e) a pedal cycle;
 - (f) a vehicle being used in connection with any building operation or demolition in or adjacent to the Bus Lane, the maintenance, improvement or reconstruction of the Bus Lane or adjacent footways, the laying, erection, alteration or maintenance in or adjacent to the Bus Lane of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line is defined in the Telegraph Act 1878 PROVIDED THAT the vehicle cannot conveniently be used for such purpose elsewhere than in the Bus Lane;
 - (g) a vehicle being used in connection with the loading or unloading of goods or merchandise to or from premises adjacent to and accessible only from the Bus Lane PROVIDED THAT such loading and unloading takes place only whilst no prohibition of loading and unloading in the Bus Lane by virtue of this or any other Order is in force; and
 - (h) a vehicle being used for the convenience of persons to or from premises adjacent to the Bus Lane PROVIDED THAT the boarding or alighting does not cause the vehicle to wait in the same place for more than two minutes and PROVIDED THAT such vehicle shall

proceed to gain access to or from such premises across the Bus Lane using the shortest possible route

PART 5 – PROHIBITION OF DRIVING AT JUNCTION – ANY VEHICLE

14. Save as provided in Article 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to enter or leave the roads specified in Column 1 of Schedule 5 to this Order at their respective junctions with the roads specified in Column 2 of the said Schedule.
15. Nothing in Article 14 of this Order shall apply to:-
- (a) any police, fire brigade or ambulance vehicle on emergency call;
 - (b) a stage carriage, scheduled express carriage, school bus or works bus where so specified in the said Schedule by reference to this part of this Article;
 - (c) say abnormal indivisible load, engineering plant and any other vehicles carrying wide loads which are subject to Part III of the Motor Vehicles (Authorisation of Special Types) General Order 1973 where so specified in the said Schedule by reference to this part of this Article.

PART 6 – PROHIBITION OF THROUGH TRAFFIC – MOTOR VEHICLES

16. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle to proceed from the roads specified in Column 1 of Schedule 6 to this Order to the roads specified in Column 2 of the said Schedule along any of the roads or lengths of road specified in Column 3 of the said Schedule.
17. (a) Nothing in Article 16 of this Order shall apply to items 4 and 8 of the said Schedule, if the vehicle is proceeding along Swinburne Street in order to gain access to the premises situated therein;
- (b) Nothing in Article 16 of this Order shall apply to items 3 and 6 of the said Schedule, if the vehicle is being used to gain access or egress from premises situated in Newton Street or Stephenson Street.

PART 7 – PROHIBITION OF ENTRY

18. Save as provided in Article 20 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle proceeding in the roads specified in Column 1 of Part 1 of Schedule 7 to this Order to enter into the roads specified in relation to those roads in Column 2 of the said Part of the said Schedule.
19. Save as provided in Articles 20 and 21 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle proceeding in the roads specified in Column 1 of Part II of Schedule 7 to this Order to enter into the roads specified in relation to those roads in Column 2 of the said Part of the said Schedule.
20. Nothing in Articles 18 and 19 of this Order shall apply to any police, fire brigade or ambulance vehicles on emergency call.
21. Nothing in Article 19 of this Order shall apply to any stage carriage, scheduled express carriage, school bus or works bus.
22. Save as provided in Article 23 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle proceeding in the roads specified in Column 1 of Part III of Schedule 7 to this Order to enter into the roads specified in relation to those roads in Column 2 of the said Part of the said Schedule.
23. Nothing in Article 22 of this Order shall apply to:-
 - (a) any public service vehicle,
 - (b) any police, fire brigade or ambulance vehicles on emergency call,
 - (c) any vehicle, if it cannot conveniently be used for such purpose in any other road, to be used for the servicing and operation of the Gateshead Metro Interchange.

24. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle proceeding in the road specified in Column 1 of Part 1 of Schedule 8 to this Order to enter into the road specified in relation to that road in Column 2 of the said Part of the said Schedule.
25. Save as provided in Article 27 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle proceeding in the roads specified in Column 1 of Part II of Schedule 8 to this Order to enter into the roads specified in relation to those roads in Column 2 of the said Part of the said Schedule.
26. Save as provided in Articles 27 and 28 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle proceeding in the road specified in Column 1 of Part III of Schedule 8 to this Order to enter into the road specified in relation to that Road in Column 2 of the said Part of the said Schedule.
27. Nothing in Articles 25 and 26 of this Order shall apply to a vehicle requiring access to premises situated on or near the affected roads.
28. Nothing in Article 26 of this Order shall apply to any stage carriage, scheduled express carriage, school bus or works bus.

PART 8 – ONE WAY RESTRICTIONS

29. Save as provided in Article 30 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to proceed in the lengths of road specified in Column 1 of Part I of Schedule 9 to this Order in a direction other than that specified in Column 2 of the said Part of the said Schedule.
30. (a) Nothing in Article 29 of this Order shall apply to the driving of any mechanical road cleansing vehicle during the times specified in Column 3 of the said part of the said Schedule.

- (b) Nothing in Article 29 of this Order shall apply to any police, fire brigade or ambulance vehicle on emergency call where so specified in Column 3 of the said part of the said Schedule.
- 31. Save as provided in Article 32 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle other than stage carriage, scheduled express carriage, school bus or works bus to proceed in the roads and in the direction specified in Part II of Schedule 9 to this Order.
- 32. Nothing in Article 31 of this Order shall apply to:-
 - (a) any mechanical road cleansing vehicle being used on any of the roads or lengths of roads aforesaid between the hours of 11.30pm on any day and 6.30am on the following day:
 - (b) any police, fire brigade or ambulance vehicle on emergency call;
 - (c) any vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
 - (d) any vehicle requiring access to the premises in the lengths of roads specified in item 2, 3 and 4(iii) of Part II of Schedule 9 to this Order.

PART 9 – TURNING RESTRICTIONS

- 33. No person shall cause or permit any vehicle proceeding in the roads specified in Column 1 of Schedule 10 to this Order to make a right hand turn into the roads specified in Column 2 of the said Schedule.
- 34. Nothing in Article 33 of this Order shall apply to any stage carriage, scheduled express carriage, school bus or works bus only insofar as it relates to the roads specified in item 17 of the said Schedule.

35. No person shall cause or permit any vehicle proceedings in the road specified in Column 1 of Schedule II to this Order to make a left hand turn into the road specified in Column 2 of the said Schedule.
36. (a) No person shall cause or permit any vehicle proceedings in the roads or carriageways of roads specified in Column 1 of Schedule 12 to this Order in the direction specified in relation to that road or carriageway of road in Column 2 of the said Schedule, to make a 'U' turn so as to proceed in the opposite direction.
- (b) Nothing in Part (a) above shall apply to the following vehicles where so specified in the said Schedule by reference to this Part of this Article:-
- (i) a vehicle carrying abnormal loads which are subject to Part III of the Motor Vehicles (Authorisation of Special Types) General Order 1973;
 - (ii) any police, fire brigade or ambulance vehicle on emergency call.

PART 10 – WEIGHT RESTRICTIONS

37. Save as provided in Article 38 of this Order no person shall cause any vehicle the weight of which, whether laden or unladen, exceeds 3 tons to proceed in the lengths of road specified in Schedule 13 to this Order.
38. Nothing in Articles 37, 39, 40, 43 and 45 of this Order shall apply to:-
- (a) any vehicle being used in connection with the removal of any obstruction to traffic in those lengths of road, the maintenance, improvement or reconstruction of those lengths of road, or the laying, erection, alteration or maintenance in or adjacent to those lengths of road of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
 - (b) any police, fire brigade or ambulance vehicles or emergency call;

- (c) any vehicle being used for the conveyance of persons, goods or merchandise to or from any premises situate on or adjacent to those lengths of road.
- 39. Save as provided in Articles 38 and 42 of this Order no person shall cause any heavy commercial vehicle to proceed in the lengths of road specified in Part I of Schedule 14 to this Order.
- 40. Save as provided in Articles 38, 41 and 42 of this Order no person shall cause any heavy commercial vehicle to proceed in the lengths of road specified in Part II of Schedule 14 to this Order.
- 41. The Council is satisfied that for preserving or improving the amenities of the areas through which the lengths of road specified in Part II of Schedule 14 to this Order run, by restricting the use of the said roads by heavy commercial vehicles, it is requisite that Section 1(5) of the Act of 1967 should not apply in relation to this Part of this Order.
- 42. Nothing in Articles 39, 40 and 43 of this Order shall apply to:-
 - (a) any vehicle proceedings to or from any premises which are situated on or adjacent to any of the said lengths of road and at which the vehicle is to be or has been, garaged, serviced or repaired;
 - (b) any vehicle being used in the service of a local authority or water authority in pursuance of statutory powers or duties;
 - (c) any vehicle being used for or in connection with the conveyance of goods for sale from the vehicle.
- 43. Save as provided in Article 38, 42 and 44 of this Order no person shall cause any heavy commercial vehicle of over 3 tons unladen weight to proceed in the lengths of road specified in Schedule 15 to this Order.
- 44. Nothing in Article 43 of this Order shall apply to any stage carriage, scheduled express carriage, school bus or works bus.

45. Save as provided in Article 38 of this Order no person shall cause any motor vehicle, the unladen weight of which exceeds 30 hundred weights, to proceed in the length of road specified in Schedule 16 to this Order.

PART 11 – PROHIBITION OF WIDE VEHICLES

46. Save as provided in Article 47 of this Order no person shall cause any vehicle the width of which, inclusive of any load on the vehicle, exceeds 9 feet (2.7 metres), to proceed on the length of road specified in Schedule 17 to this Order.
47. Nothing in Article 46 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the length of road specified in that Article if the vehicle is being used:-
- (a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road; or
 - (b) for the purpose of agriculture in connection with land adjacent to that length of road or for the conveyance or haulage of timber felled upon that land; or
 - (c) in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or maintenance in or adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878.

PART 12 – PROHIBITION OF PEDESTRIANS

48. In this part:-

“relevant traffic sign” means the sign shown in diagram 625.1 of Schedule 1 to the Traffic Signs Regulations and General Directions 1981.

49. Save as provided in Article 50 of this Order no foot passenger shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, proceed on to or in the length of carriageway specified in Part I of Schedule 18 to this Order.
50. Nothing in Article 49 of this Order shall apply to:-
- (a) persons employed in the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road; or
 - (b) a foot passenger using the length of road so specified in connection with any emergency relating to the breakdown of or accident to a vehicle on the said length of road.
51. No foot passenger shall proceed in the road or length of road specified in Part II of Schedule 18 to this Order when the relevant traffic sign is displayed.

PART 13 – PROHIBITION OF WAITING AT ANY TIME

52. Save as provided in Articles 53 and 54 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the lengths of roads or sides of lengths of roads specified in Schedule 19 to this Order.
53. (1) Nothing in Articles 52 and 56 to 78 (inclusive) of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-
- (a) the picking up and setting down of passengers;
 - (b) goods to be loaded onto or unloaded from the vehicle except in the same lengths of road as may be specified in Schedules 47 to 53 (inclusive);
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any or the following operations namely:-
 - (i) building or demolition operations,
 - (ii) the removal of any obstruction to traffic,

- (iii) the maintenance, improvement or reconstruction of the said roads,
 - (iv) the laying, erection, alteration or maintenance in or in land adjacent to the said lengths of road of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or water authority in pursuance of statutory powers or duties;
 - (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
- (2) Nothing in Articles 52 and 56 to 77 (inclusive) of this Order shall apply to a vehicle being used for police, fire brigade or ambulance purposes;
- (3) Nothing in Articles 52 and 56 to 77 (inclusive) of this Order shall render it unlawful to cause or permit the following vehicles to wait:-
- (a) a Hackney Carriage (as defined in the Vehicle (Excise) Act 1971) waiting at a duly authorised cab rank;
 - (b) a vehicle waiting on a parking place duly authorised by an Order made under the Act of 1967, provided that the vehicle is parked in accordance with the provisions of such an Order.
54. Nothing in Articles 52 and 56 to 62 (inclusive) of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a disabled person's parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in the lengths of road referred to therein for a period not exceeding two hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day).

 - (iv) the laying, erection, alteration or maintenance in or near such roads of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
 - (b) to a vehicle being used for police, fire brigade or ambulance purposes;
 - (c) to a vehicle being used in the service of a local authority or water authority in pursuance of statutory powers or duties;

- (d) to a vehicle being used for the purposes of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
- (e) to a vehicle on the carriageways referred to in that Article while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than on that carriageway;
- (f) to a vehicle waiting when the person in control of the vehicle:-
 - (i) is required by law to stop;
 - (ii) is obliged to stop in order to avoid an accident; or
 - (iii) is prevented from proceeding by circumstances outside his control;
- (g) to a stage carriage, scheduled express carriage, school bus or works bus where so specified in Column 3 of the said Schedule.

81. No person shall cause or permit any vehicle to wait on any verge or layby immediately adjacent to any of the main carriageways comprised in the roads specified in Article 79 to this Order for the purpose of selling goods from that vehicle unless the goods are immediately delivered at or taken into premises adjacent to that vehicle from which the sale is effected.

PART 38 – PEAK HOUR CLEARWAY

82. (1) In this part of this Order –

“prescribed hours” means the time between the hours of 8.00am and 9.15am and between 4.00pm and 6.00pm Monday to Friday (inclusive)

“specified road” means the length of road specified in Schedule 44 to this Order.

(2) A vehicle shall be deemed to wait for more than two minutes in the same place in the specified road if any point in that road is below the

vehicle or its load (if any) throughout a period exceeding two minutes whether or not the vehicle is moved during the period in question.

- (d) a hackney carriage waiting at a duly authorised cab rank.

(3) Nothing in Article 83 of this Order shall render it unlawful to cause or permit a vehicle to wait in a specified road during the prescribed hours for so long as may be necessary:-

- (a) for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
- (b) to enable the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any

building or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of a specified road or the laying, erection, alteration or maintenance in or near a specified road of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;

- (c) for the closing of any gate or barrier at the entrance to premises to which the vehicle requires access or from which it has emerged if it is not reasonably practicable for the vehicle to wait otherwise than in the specified road while such gate or barrier is opened or closed.

- (4) Nothing in Article 83 of this Order shall render it unlawful to cause or permit any vehicle to wait in any case where the person in control of the vehicle is required by law to stop, or is obliged to stop in order to avoid an accident, or is prevented from proceeding by circumstances outside his control.

PART 39 – BUS STOP CLEARWAYS

- 85. Save as provided in Article 86 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle other than a stage carriage or scheduled express carriage to wait during the hours of 7.00am to 7.00pm on any day in any prohibited area in any road specified in Schedule 45 to this Order.

- 86. Nothing in Article 85 of this Order shall render it unlawful to cause or permit a vehicle to wait in a prohibited area:-

- (a) if the vehicle is being used for the removal of any obstruction to traffic;
- (b) if the vehicle is being used in the service of the Council or with the permission of the Council in exercise of statutory powers or duties and whilst being so used in such service it is necessary for the vehicle to wait in that prohibited area;
- (c) in any case where the person in control of the vehicle –
 - (i) is required by law to stop;
 - (ii) is obliged to stop in order to avoid an accident; or

- (iii) is prevented from proceeding by circumstances outside his control;
- (d) if the vehicle is being used for police, fire brigade or ambulance purposes.

PART 40 – BOXED AREAS

87. In this part of this Order references to a boxed area the reference to any of those areas of the carriageways of the roads specified in Schedule 46 to this Order which are situated at or near the junctions of two or more roads specified in the same paragraph of that Schedule and are marked by traffic signs consisting of cross-hatched yellow lines bounded by a yellow line placed on the carriageway being of the type shown in Diagram 1043 and 1044 of the Traffic Signs Regulations and General Directions 1981.
88. Save as provided in Article 89 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, drive a vehicle into a boxed area and thereafter drive it in such a direction that it becomes necessary owing to the presence of one or more stationary vehicles, for any part of the vehicle to remain at rest within the boxed area. PROVIDED that no driver of a vehicle which is caused to remain at rest within the boxed area shall be guilty of an offence if at the time he drove onto the boxed area he had reasonable cause to believe that he would immediately thereafter be able to drive the vehicle wholly out of the area.
89. Nothing in Article 88 of this Order shall apply:-
- (a) so as to prohibit the driving of a vehicle into a boxed area by a person who thereafter drives it to a position where he can conveniently wait to make a right hand turn and who is then prevented from driving out of the boxed area by reason of the presence of other stationary vehicles in or near the area waiting to complete a right hand turn; or
 - (b) in relation to vehicles being used for police, fire brigade or ambulance purposes.

No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the lengths of road specified in Schedule 47 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
91. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait between the hours of 8.00am and 10.00am and the hours of 4.00pm and 6.00pm any day on the lengths of road specified in Schedule 48 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
92. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 8.00am and 9.30am and the hours of 4.00pm and 6.00pm any day on the length of road specified in Schedule 49 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicles, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
93. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm Monday to Saturday (inclusive) on the lengths of road specified in Schedule 50 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
94. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 7.30am and 9.30am and the hours of 4.30pm and 6.30pm on any day on the lengths of road specified in Schedule 51 to this

Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.

95. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 8.00am and 9.15am and the hours of 4.00pm and 6.00pm Monday to Saturday (inclusive) on the lengths of road specified in Schedule 52 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
96. No person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 10.00am and 8.00am Monday to Saturday (inclusive) on the length of road specified in Schedule 53 to this Order for the purpose of enabling goods to be loaded onto or unloaded from the vehicle, unless the vehicle is in actual use for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
97. The restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act of 1967, or by or under any other enactment.
98. This Order shall come into operation on 19th April 1982, and may be cited as the Tyne and Wear County Council (The Metropolitan Borough of Gateshead) Traffic Regulation (Consolidation) Order 1982.
