THE BOROUGH COUNCIL OF GATESHEAD (CIVIC CENTRE) OFF STREET PARKING PLACES (AMENDMENT NO 1) ORDER 2012

The Borough Council of Gateshead ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and by virtue of the Traffic Management Act 2004 and of all other enabling powers in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order :-

Commencement and Citation

1. This Order shall come into operation on 1st January 2013 and may be cited as "The Borough Council of Gateshead (Civic Centre) Off Street Parking Places (Amendment No 1) Order 2012".

Revocation and Amendment to the Borough Council of Gateshead (Civic Centre) Off Street Parking Places Order 2012

2. The Borough Council of Gateshead (Civic Centre) Off Street Parking Places Order 2012 is amended as follows:

- (i) In the Construction and Interpretation Article 5, in the definition relating to "Permit" after the words "Exemption Permit" insert the words "Staff Mobility Permit".
- (ii) In the Construction and Interpretation Article 5 after the definition relating to 'Reserved Space', insert the following new definition:-

"Staff Mobility Permit" means a permit issued to an employee of the Council, who holds a disabled person's badge and is deemed to meet the eligibility criteria for a Staff Mobility Permit in accordance with the Staff Parking Permit Protocol.

- (iii) In the Construction and Interpretation Article 5, after the definition relating to 'Staff Parking Permit', insert the following new definition:-

"Staff Parking Permit Protocol" means such Protocol as the Service Director, Transport Strategy shall issue or amend from time to time for the purpose of regulating Staff Parking Permits, including eligibility criteria, application process, conditions of use and such other matters as are appropriate for the efficient and effective operation of the scheme.

- (iv) In the Construction and Interpretation Article 5, delete the definition relating to 'Plan' and replace it with the new definition below:-

"Plan" means the plans attached to this Order which show for identification purposes only the location and extent of the parking place referred to in Column 1 of Schedule 1.

- (v) In the Construction and Interpretation Article 5, after the definition relating to 'Vehicle', insert the following new definition:-

"30 Minute Bay" means a parking space coloured green within the parking place known as Prince Consort Road Car Park as described in Schedule 2 to this Order and specified in Column 1 of Schedule 1 to this Order.

- (vi) In the Construction and Interpretation Article 5, delete the definition relating to 'Member Parking Permit' and replace it with the new definition below:-

"Member Parking Permit" for the purposes of this Order means a Permit issued by the Council to an Elected Member of the Council or the Police and Crime Commissioner and their appointed officers".

- (vii) In the Commencement and Citation Article 1, after the words 'cited as' delete the title of "The Borough Council of Gateshead (Civic Centre) Off Street Parking Places Order 2012" and replace it with "The Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012".

- (viii) Revoke Schedule 1 in its entirety and replace it with the new Schedule 1 below:-

- (ix) In Schedule 2 'Description of Parking Places', revoke Schedule 2 in its entirety and replace it with the new Schedule 2 below:-

“ **Schedule 2**

1. Civic Centre Car Park A means 9850 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 98 parking spaces shown for identification purposes only and hatched in green on Plan No 1 attached to this Order
2. Civic Centre Car Park B means 3077 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 203 parking spaces shown for identification purposes only edged and hatched in green on Plan No 2A attached to this Order
3. Civic Centre Car Park C means 3025 square metres or thereabouts of the lower level one and 3025 square metres of the lower level two car park located on the north west side of Arthur Street Gateshead comprising of 254 spaces shown for identification purposes only edged and hatched green on Plan No 3 attached to this Order.
4. Civic Centre Car Park D means 306 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 14 parking spaces shown for identification purposes only edged and hatched in green on Plan No 11 attached to this Order
5. Computer House Car Park means the car park containing an area of 1103 metres or thereabouts located to the east of the High Street Gateshead approximately 65 metre south of the junction of High Street and St Bede's Drive to the south of the southern boundary of the building known as Computer House shown for identification purposes only edged and hatched in green on Plan 4 attached to this Order.
6. Gateshead Leisure Centre Car Park means the car park containing an area of 1539 square metres or thereabouts located to the south east of the junction of Alexandra Road and St Alban's Terrace (including the area shown adjacent to the eastern boundary of the Gateshead Leisure Centre) shown for identification purposes only edged and hatched green on Plan 5 attached to this Order.
7. Prince Consort Road Car Park means the car park containing an area of 2176 square metres or thereabouts located to the south of

the junction of Prince Consort Road Gateshead and St Alban's Terrace shown for identification purposes only edged and hatched green on Plan 6 attached to this Order containing approximately 88 parking spaces.

8. Sunderland Road (Tynegate) Car Park means the car park containing an area of 989 square metres and shown for identification purposes only edged and hatched green on Plan 7 attached to this Order and containing approximately 34 parking spaces.
9. Swinburne Street Car Park means the car park containing an area of 1259 square metres or thereabouts located to the north of Swinburne Street Gateshead between its junctions with West Street and Nelson Street shown for identification purposes only edged and hatched green on Plan 8 attached to this Order containing approximately 57 parking spaces.
10. Town Hall Car Park means the car park containing an area of 7989 square metres or thereabouts located to the west of West Street Gateshead directly opposite its junction with Swinburne Street and to the east of the Gateshead West Central Route shown for identification purposes only edged and hatched green on Plan 9 to this Order containing approximately 52 parking spaces.
11. Windmill Hills Car Park means the car park located off the south east side of Bensham Road Gateshead containing an area of 2232 square metres or thereabouts accessed from Bensham Road at a point 105 metres south west of the southern kerb line of its junction with Coatsworth Road shown for identification purposes only edged and hatched green on Plan 10 to this Order containing approximately 56 parking spaces."

(x) After Article 7A insert the following new Articles:-

"7B (i) Subject to Article 7B(ii) and Article 28 of this Order, a vehicle may be left in a parking place specified in Column 1 of Schedule 1 on the days and between the hours specified in Column 4 of Schedule 1.

7B (ii) The driver of a vehicle using the parking place known as Prince Consort Road Car Park shall not leave a vehicle in that parking place:-

- (a) for a period longer than 30 minutes in the 30 minute bays ;
- (b) for a period longer than two hours in all other bays between the hours of 8am to 5pm Monday to Friday;
- (c) if a period of less than two hours has elapsed since the termination of the last period in which the vehicle used the said parking place. "

(xi) In Article 28, after the words "save as provided in" and before the words "Article 30" insert the words "Article 29A and"

(xii) After Article 29 (f) insert the following new Article:

"29A Nothing in Articles 28 or 29 shall apply to a vehicle using the parking place known as Prince Consort Road Car Park, Civic Centre Car Park D or the Leisure Centre Car Park after 5pm from Monday to Friday (inclusive)";

(xiii) In Article 30 (1) after the words "the following vehicles only when left" delete the words " in a parking space reserved for disabled persons vehicles within the parking place known as Civic Centre Car Park A or within a pay and display parking space" and replace with:-

" in a parking place specified in Column 1 of Schedule 1, on the days and during the hours a parking place is not reserved for vehicles displaying a permit" before the words "the following vehicles only when left", before the words "will be exempt".

(xiv) After Article 30 insert the following new Article:

" 30A A vehicle displaying a Staff Mobility Permit, shall be exempt from the payment of a charge specified in Column 7 of Schedule 1 of this Order under the provisions of Article 28 of this Order, provided it is parked in a permit bay. "

(xv) In Article 33 (a) insert the following new subsection (ii) after subsection (a)(i);

" An employee of the Council who is deemed to be eligible for a Staff Mobility Permit on application and at the discretion of the Council in accordance with the Staff Parking Permit Protocol shall be issued with a Staff Mobility Permit free of charge and the permit shall be valid in such parking places and parking spaces as may be specified thereon during the period for which it is issued and under the conditions stipulated thereon, subject to Articles 34, 35 and 36 of this Order"

(xvi) Article 33(a)(ii) shall be renumbered Article 33(a)(iii) and the words "Head of Transport Strategy" shall be replaced with the words "Service Director, Transport Strategy" and after the words "at their discretion" the words "in accordance with the Staff Parking Permit Protocol issued by them for this purpose" shall be inserted.

(xvii) In Article 33(a)(i) after the words 'or an elected member of the Council', delete the words 'or a member of Northumbria Police Authority' and replace them with the following new wording of:-

"or the Police and Crime Commissioner and their appointed officers".

Amendments to the Borough Council of Gateshead (Off Street Parking Places Gateshead) (Consolidation Amendment No1) Order 2009

- (i) In Schedule 2 Part 1 (Parking Places) the following items and their descriptions shall be deleted:-







Computer House Car Park - Plan 4


