THE BOROUGH COUNCIL OF GATESHEAD (TOWN CENTRE) OFF STREET PARKING PLACES (AMENDMENT NO 2) ORDER 2013

The Borough Council of Gateshead ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and by virtue of the Traffic Management Act 2004 and of all other enabling powers in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order :-

Commencement and Citation

1. This Order shall come into operation on 13th day of September 2013 and may be cited as "The Borough Council of Gateshead (Town Centre) Off Street Parking Places (Amendment No 2) Order 2013".

Revocation and Amendment to the Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012

2. The Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012 is amended as follows:

(i) In Schedule 1, after the item relating to 'Prince Consort Road Car Park', insert the new 'Hilda House Car Park' Item below:-

(iv) In Schedule 2, Plan No 1 and Item 1 relating to 'Civic Centre Car Park A', shall be revoked in their entirety and replaced with the following new Item 1 and Plan No 1(A) below:-

"1. Civic Centre Car Park A means 4050 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 127 parking spaces shown for identification purposes only edged and hatched green on Plan No 1(A) attached to this Order".

(v) In Schedule 2, Plan No 2A and Item 2 relating to 'Civic Centre Car Park B', shall be revoked in their entirety and replaced with the following new Item 2 and Plan No 2(B) below:-

"2. Civic Centre Car Park B means 6020 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 184 parking spaces shown for identification purposes only edged and hatched in green on Plan No 2(B) attached to this Order".

(vi) In Schedule 2, after Item 11 relating to 'Windmill Hills Car Park', insert the new Item 12 'Hilda House Car Park and Plan No 11 below:-

"12. Hilda House Car Park means 555 square metres or thereabouts located to the southern end of St Bede's Drive Gateshead comprising 21 parking spaces shown for identification purposes only edged and hatched in green on Plan No 11 attached to this Order".

(vii) In Schedule 2, Plan No 5 and Item 6 relating to 'Gateshead Leisure Centre Car Park' shall be revoked in their entirety and replaced with the following two new Items 6 and 6A and Plans 4A and 4B below:-

"6. Gateshead Leisure Centre Car Park A means the car park containing an area of 1015 square metres or thereabouts located to the south east of the junction of Alexandra Road and St Alban's Terrace shown for identification purposes only edged and hatched in green on Plan 4A attached to this Order".

"6A. Gateshead Leisure Centre Car Park B means the car park containing an area of 505 square metres or thereabouts located between the Leisure Centre sports hall and Prince Consort Road offices shown for identification purposes only edged and hatched in green on Plan 4B attached to this Order".

(viii) In the Construction and Interpretation Article 5, revoke the definition relating to 'Staff Parking Permit' in its entirety and replace it with the new definition below:-

"Staff Parking Permit" for the purposes of this Order means a Permit issued by the Council to an employee of the Council or a tenant of the Civic Centre".

(ix) Article 7B(ii)(b) relating to 'for a period longer than two hours in all other bays between the hours of 8am to 5pm Monday to Friday' shall be revoked in its entirety and replaced with the following new Article 7B(ii)(b) below:-

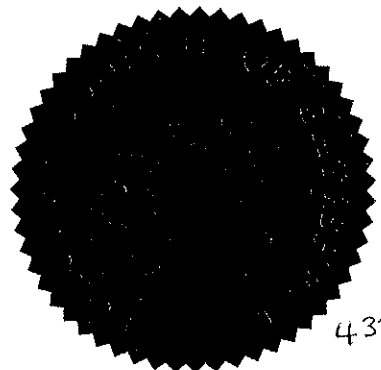
"7B(ii)(b) for a period longer than three hours in all other bays between the hours of 8am to 5pm Monday to Friday".

(x) Article 29A relating to 'Nothing in Articles 28 or 29 shall apply to a vehicle using the parking place known as Prince Consort Road Car Park, Civic Centre Car Park D or the Leisure Centre Car Park after 5pm Monday to Friday (inclusive)', shall be revoked in its entirety and replaced with the new Article 29A below:-

"29A Nothing in Articles 28 or 29 shall apply to a vehicle using the parking places known as Prince Consort Road Car Park, Civic Centre Car Park D, Gateshead Leisure Centre Car Park A after 5pm Monday to Friday (inclusive) or Gateshead Leisure Centre Car Park B".

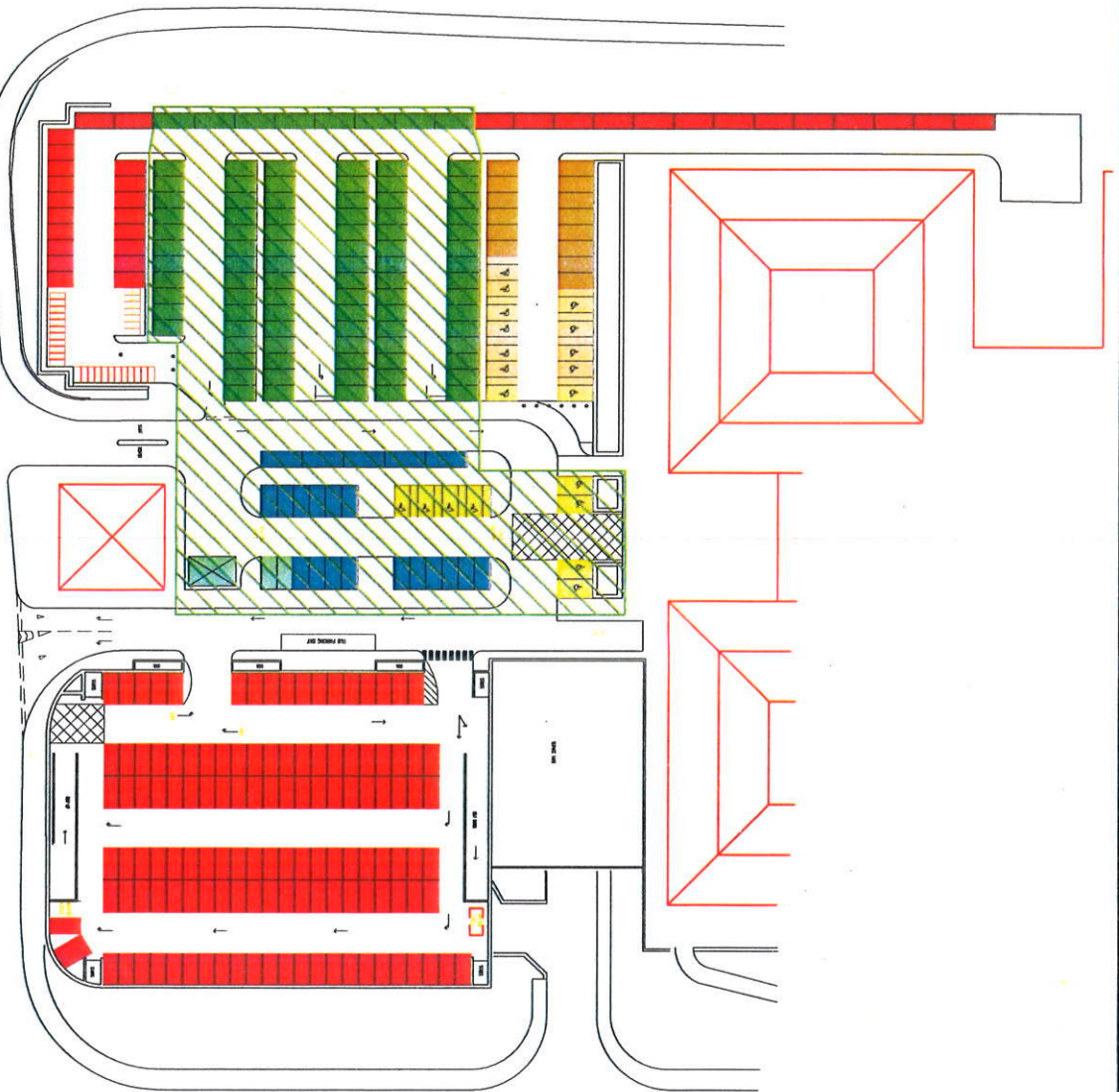

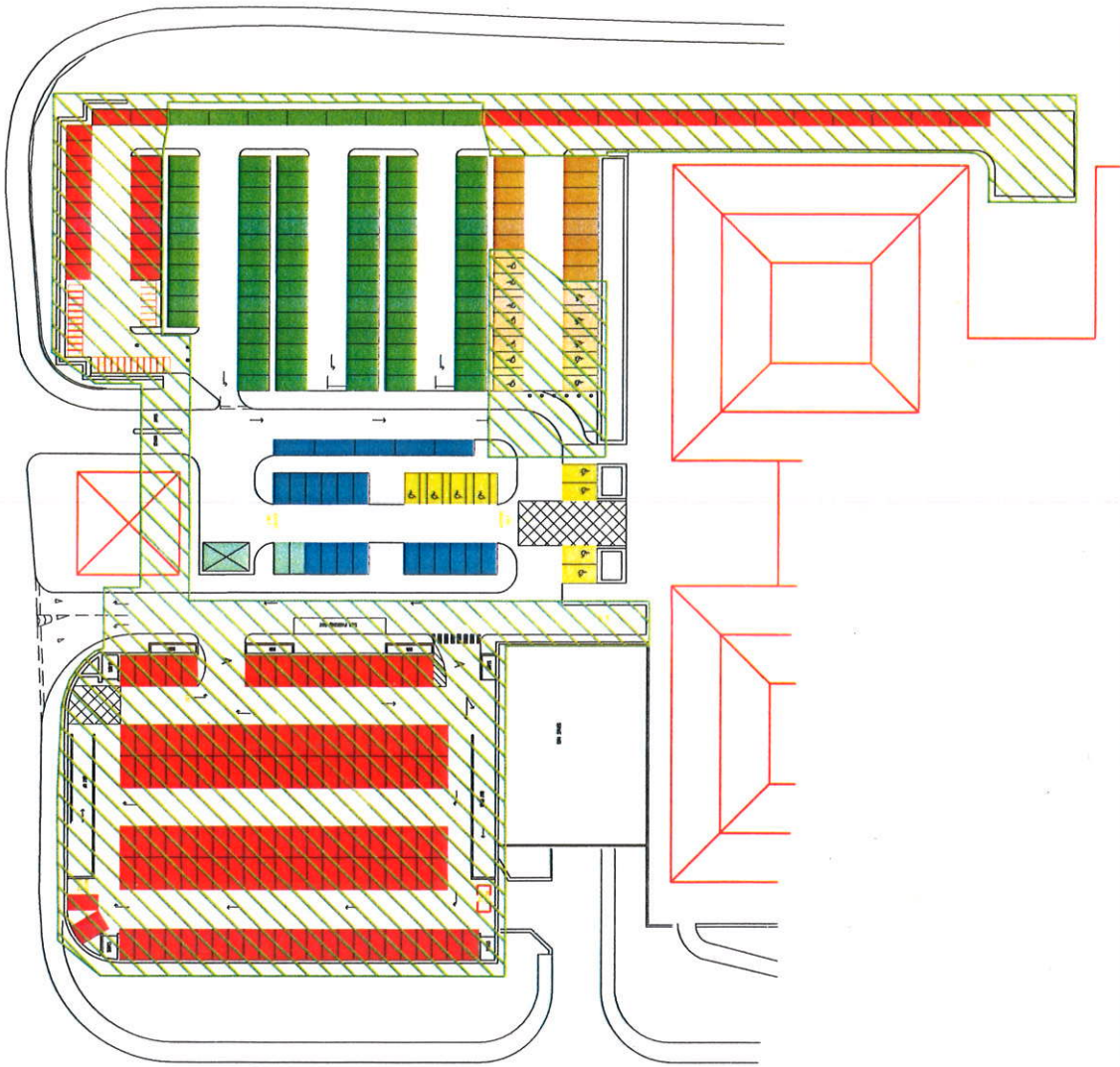

Civic Centre Car Park B Plan No 2 (B)

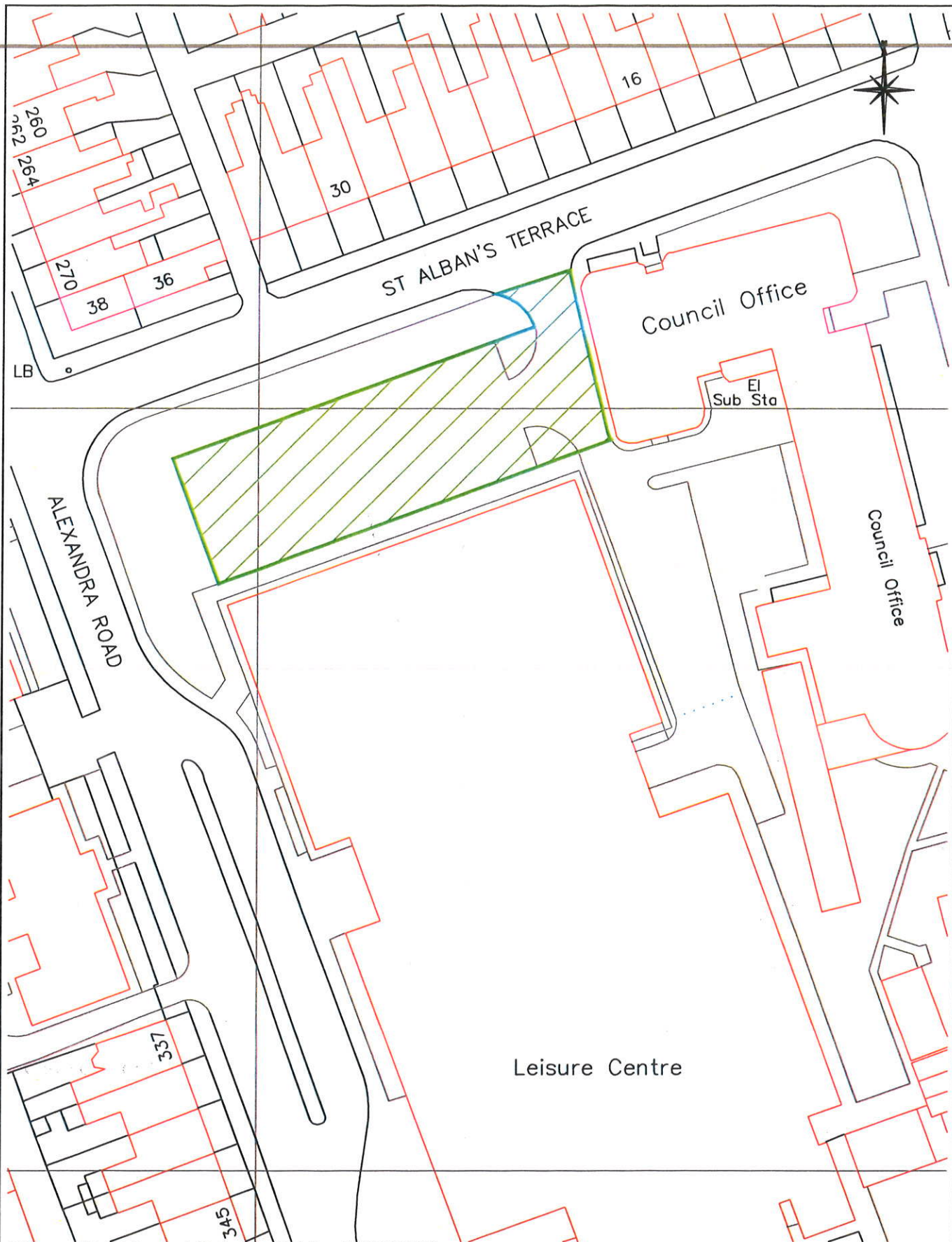

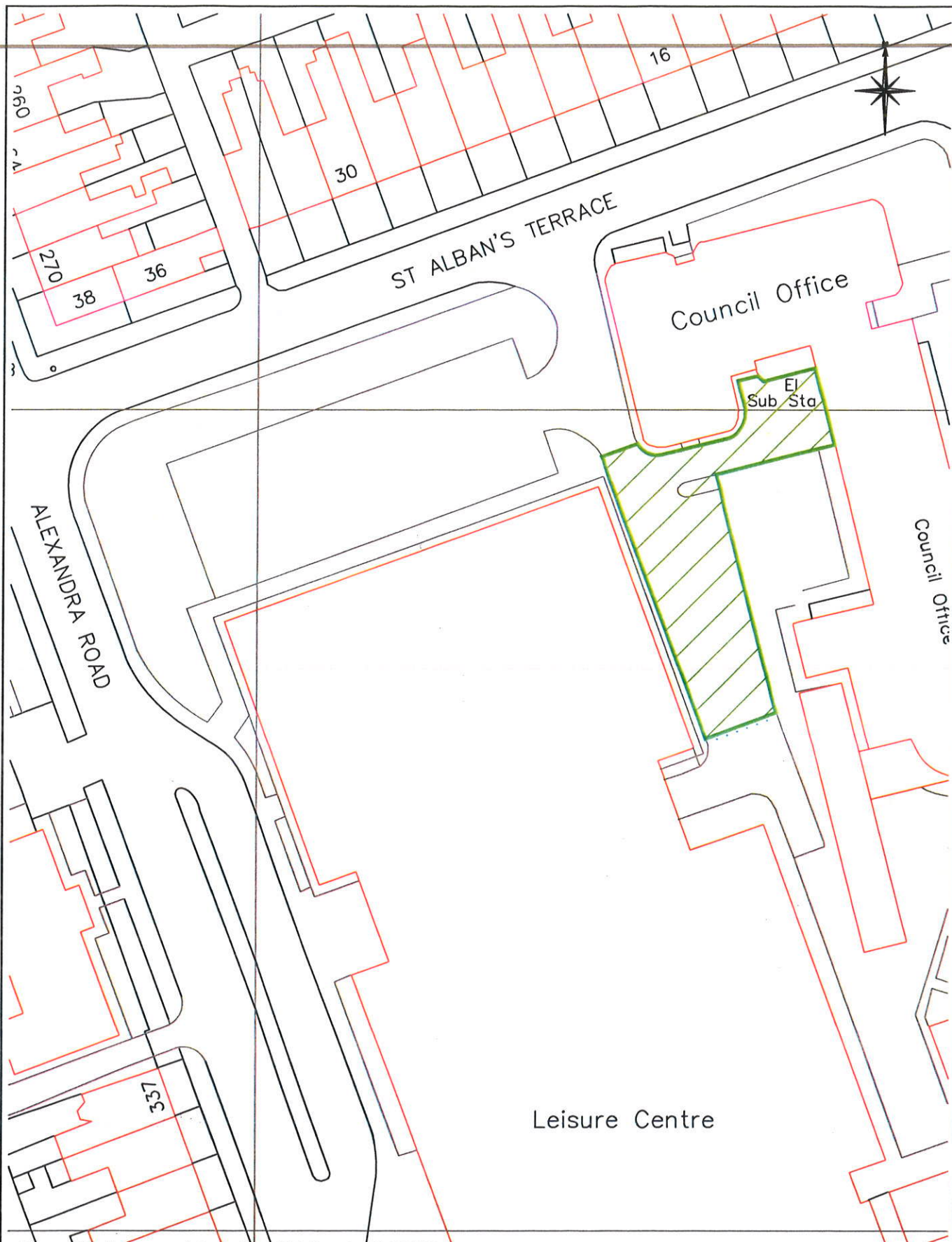
Gateshead Leisure Centre Car Park A Plan No 4A
