**THE BOROUGH COUNCIL OF GATESHEAD (OFF STREET PARKING  
PLACES GATESHEAD) CONSOLIDATION (AMENDMENT NO 3) (PART)  
ORDER 2011**

The Borough Council of Gateshead ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and by virtue of the Traffic Management Act 2004 and of all other enabling powers in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order :-

**Commencement and Citation**

1. This Order shall come into operation on 9<sup>th</sup> January 2012 and may be cited as "The Borough Council of Gateshead (Off-Street Parking Places Gateshead) Consolidation (Amendment No 3) Order 2011".

**Revocation and Amendment**

2. The Borough Council of Gateshead (Off-Street Parking Places Gateshead) Consolidation (Amendment No 1) Order 2009 is amended as follows:
  - (i) Insert into Part 1 Article 1, after 'civil enforcement officer' the following definitions:-

**"electric vehicle"** means a vehicle which uses electricity as source of power for propulsion and includes a vehicle which in addition uses or is capable of using, other sources of power for this purpose.

**"electric vehicle charging bay"** means a bay for use only by electric vehicles when in the process of re-charging the vehicle with electric.
  - (ii) In Schedule 3 '**Parking Places Without Payment**' delete the existing Schedule 3 and replace it with the new Schedule 3 below:-

- (iv) In Schedule 2 Part 1 relating to **'Parking Places'**, revoke the **'Gateshead Leisure Centre'** description and Plan No 18 in its entirety and replace it with the following new description and new Plan No 18:-

**"Gateshead Leisure Centre Car Park'** means the car park containing an area of 1539 square metres or thereabouts located to the south east of the junction of Alexandra Road and St Alban's Terrace (including the area adjacent to the eastern boundary of the Gateshead Leisure Centre) shown for identification purposes only edged and hatched in green on Plan No 18 in the Appendix to this Order containing 42 parking spaces".

- (v) In Schedule 2 Part 1 relating to **'Parking Places'**, revoke the **'Computer House Car Park'** description and Plan No 10 in its entirety and replace it with the following new description and new Plan No 10:-

**"Computer House Car Park'** means the car park containing an area of 1103 square metres or thereabouts located to the east of the High Street Gateshead approximately 65 metres south of the junction of High Street and St Bede's Drive to the south of the southern boundary of the building known as Computer House shown for identification purposes only edged and hatched in green on Plan No 10 in the Appendix to this Order containing approximately 28 parking spaces".

- (vi) In Part III relating to **'Use of Parking Places General'** after Article 8(iii)(h), insert the following new Article 8(iii)(i):-

"(i) No Vehicle shall park in any parking place or bay for a longer period than the period permitted as indicated in the parking place or bay."

- (vii) In Part III relating to **'Use of Parking Places General'** after Article 8(iii)(i), insert the following new Article 8(iii)(j):-

"(j) No Vehicle, other than an electric vehicle in the process of being charged with electricity, shall park, stop, wait or otherwise be in any parking place or bay which has been reserved and is signed as an electric vehicle charging place or bay."




