

**THE BOROUGH COUNCIL OF GATESHEAD (A694 BLAYDON,
GATESHEAD) (SPEED LIMIT REVIEW) TRAFFIC REGULATION ORDER
2016**

The Borough Council of Gateshead (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 82, 83, 84 of The Road Traffic Regulation Act 1984 (“the 1984 Act”) and Part IV of Schedule 9 to the 1984 Act and by virtue of the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

PART I

Amendments to The Borough Council of Gateshead (Speed Limits) (Consolidation) Order 2009

1. The Borough Council of Gateshead (Speed Limits) (Consolidation) Order 2009 is amended as follows:
2. In Schedule 4 Part I ‘40mph Speed Limit’, revoke Item 3 relating to ‘A694 Lockhaugh Road’, Item 4 relating to ‘A694 Road, Winlaton’ and Item 30 relating to ‘Spa Well Road’, in their entirety and replace them with the revised descriptions below:

3.	A694 Spa Well Road	From a 210 metres north east of its junction with Noel Avenue in a north easterly direction to a point 56 metres south of its junction with Hexham Road for a total distance of 1545 metres.
4.	A694 Lockhaugh Road	From a point 90 metres north east of its junction with Thornley Avenue in a north easterly direction to a point 555 metres south west of its junction with Noel Avenue for a total distance of 1205 metres.
30.	A694 Lintzford Lane	From a point 450 metres south west of its junction with Lintzford Lane in a north easterly direction for a total length of 1370 metres.

3. In Schedule 8 ‘Restricted Roads (30mph Speed Limit)’, after Item 12 relating to ‘Woodside Lane, Ryton’, insert the following two new Items 13 and 14 below:

13.	A694 Lockhaugh Road	From a point 255 metres north of its junction with Burnopfield Lane in a north easterly direction to a point 89 metres north east of its junction with Thornley Lane for a total distance of 1385 metres.
