

**NOTICE OF CONFIRMATION OF AN ORDER (OTHER THAN AN ACQUISITION  
EXTINGUISHMENT ORDER)  
HIGHWAYS ACT 1980  
THE BOROUGH COUNCIL OF GATESHEAD  
THE BOROUGH COUNCIL OF GATESHEAD (BRIDLEWAY FELLING 50) PUBLIC PATH  
CREATION ORDER 2016**


On 6<sup>th</sup> April 2017 the Borough Council of Gateshead confirmed the above order made under section 26 of the Highways Act 1980.

The effect of the order as confirmed is to create a bridleway from its junction with Joel Terrace, at Point A on the order map grid reference NZ29626284, Bridleway Felling 50 proceeds in an easterly direction then turns to proceed in a north easterly direction to its junction with Footpath Felling 16 at Point B on the order map grid reference NZ29946332, where it then turns easterly to Point C on the order map grid reference NZ30036340 then turns north easterly to the South Tyneside Borough Boundary at Point D on the order map grid reference NZ30046343 where it proceeds in a south westerly direction to its junction with the turning circle on Brack Terrace at Point E on the order map grid reference NZ29776271, for a distance of approximately 1508 metres, at a width of 3 metres throughout as shown on the order map.

A copy of the order as confirmed and the order map have been placed and may be seen free of charge at the offices of the Strategic Director of Corporate Services and Governance, on the ground floor of the Civic Centre, Regent Street, Gateshead NE8 1HH Monday to Thursday between 8.30am and 5.30pm and Friday between 8.30am and 5.00pm. The order comes into force as from 6<sup>th</sup> April 2017, but if any person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 11<sup>th</sup> April 2017, make an application to the High Court.
