THE BOROUGH COUNCIL OF GATESHEAD
(GATESHEAD TOWN CENTRE OFF-STREET CAR PARKS AND GATESHEAD OFF-STREET CAR PARKS) (AMENDMENT NO 4) TRAFFIC REGULATION ORDER 2016

The Borough Council of Gateshead ("hereinafter referred to as the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32, 33 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), by virtue of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Northumbria Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

PART I

Amendments to the Borough Council of Gateshead (Off-Street Parking Places Gateshead) Consolidation (Amendment No 1) Traffic Regulation Order 2009

1. Amendments to the Borough Council of Gateshead (Off-Street Parking Places Gateshead) Consolidation (Amendment No 1) Traffic Regulation Order 2009:
2. In Part 1 'Interpretation' above the Item relating to "relevant position" insert the following new definition of:

 " **"restricted area"** means a defined area of a parking place, bordered with a bold yellow or white line and containing yellow or white hatched surface markings".
3. In Part III 'Use of Parking Places' insert after Article 27 the following new Article 28:

 "28. No person shall cause or permit any vehicle to stop, wait or park on or within any part of a restricted area at any time, unless authorised by the Council in writing or by a Civil Enforcement Officer".
4. In Schedule 2 Part 1 'Parking Places', revoke the Item, description and plan Number 2A relating to 'Back High Street / Back Jackson Street' in their entirety.
5. In Schedule 4 'Charged Parking Places', revoke Item 2 relating to 'Back High Street / Back Jackson Street Car Park' in its entirety.
6. In Part V Article 4 revoke the words after the word "badge" of "with the exception of Back High Street / Back Jackson Street Car Park detailed in Schedule 4 to this Order, which will require a vehicle when parking in a disabled parking bay, to display in the relevant position both a valid disabled person's badge and a seasonal permit", in their entirety.
7. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Back Regent Terrace / Back Walker Terrace Car Park', the following new wording:

 "**Seasonal Permit (Specified Days)** - £163.00 per day per annum".
8. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Church Street Car Park', the following new wording:

"Seasonal Permit (Specified Days) - £181.00 per day per annum".

9. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Garden Street Car Park', the following new wording:

"Seasonal Permit (Specified Days) - £181.00 per day per annum".

10. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Heworth North Car Park (Metro Station)', the following new wording:

"Seasonal Permit (Specified Days) - £78.00 per day per annum".

11. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Mill Road Car Park', the following new wording:

"Seasonal Permit (Specified Days) - £223.00 per day per annum".

12. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'Regent Court Car Park', the following new wording:

"Seasonal Permit (Specified Days) - £163.00 per day per annum".

13. In Schedule 4 'Charged Parking Places', insert into the 'Current Charges' column below the words 'Seasonal Permit (all days)' of the Item relating to 'South Shore Road Car Park', the following new wording:

"Seasonal Permit (Specified Days) - £223.00 per day per annum".

PART II

Amendments to the Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012

1. Amendments to the Borough Council of Gateshead (Town Centre) Off Street Parking Places Order 2012:

2. In the 'Construction and Interpretation' Article 5, insert above the definition of 'relevant position', the following new definition of:

"restricted area" means a defined area of a parking place, bordered with a bold yellow or white line and containing yellow or white hatched surface markings".

3. In the 'Conditions of Use of Parking Places', after Article 24, insert the following new Article 25 below:

"25. No person shall cause or permit any vehicle to stop, wait or park on or within any part of a restricted area at any time, unless authorised by the Council in writing or by a Civil Enforcement Officer".

4. In Schedule 2, Item 1 and Plan No 1A relating to 'Civic Centre Car Park A', shall be revoked in its entirety and replaced with the following new Item 1 and Plan No 1(A) below:

"1. Civic Centre Car Park A means 5180 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 162 parking spaces shown for identification purposes only and hatched in green on Plan No. 1(A) attached to this Order".

5. In Schedule 2, Item 2 and Plan No 2(B) relating to 'Civic Centre Car Park B', shall be revoked in their entirety and replaced with the following new Item 2 and Plan No 2(B) below:

"2. Civic Centre Car Park B means 3440 square metres or thereabouts of ground level car park located on the north side of Arthur Street Gateshead comprising of 133 parking spaces shown for identification purposes only and hatched in green on Plan No. 2(B) attached to this Order".

6. In Schedule 2, Item 4 and Plan No. 11 relating to 'Civic Centre Car Park D', shall be revoked in their entirety and replaced with the following new Item 4 and Plan No. 11 below:

"4. Civic Centre Car Park D means 315 square metres or thereabouts of the ground level car park located on the north west side of Arthur Street Gateshead comprising of 14 parking spaces shown for identification purposes only and hatched in green on Plan No. 11 attached to this Order".

PART III

Savings and Commencement

1. In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
2. This Order shall come into operation on 18th day of April 2016 and may be cited as The Borough Council of Gateshead (Gateshead Town Centre Off-Street Car Parks and Gateshead Off-Street Car Parks) (Amendment No 4) Traffic Regulation Order 2016.

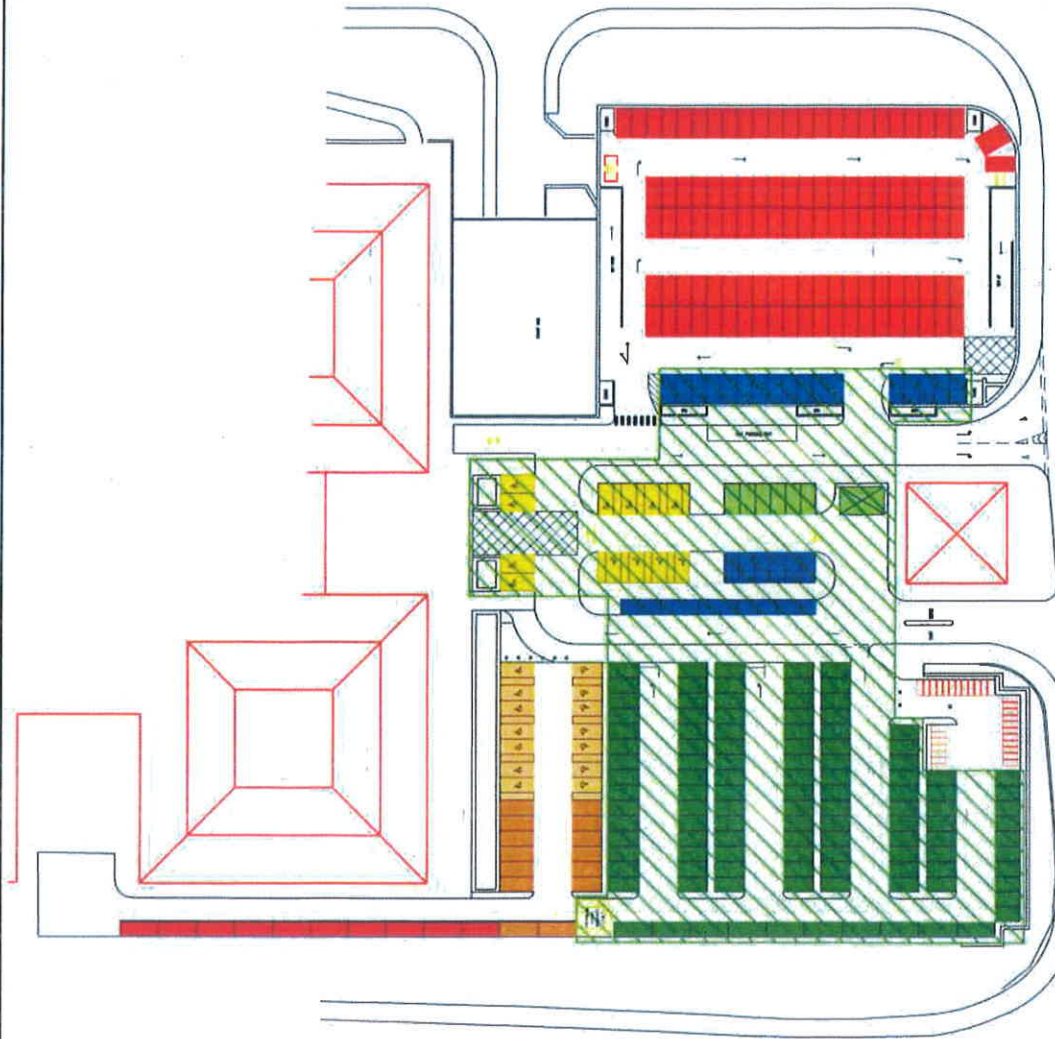

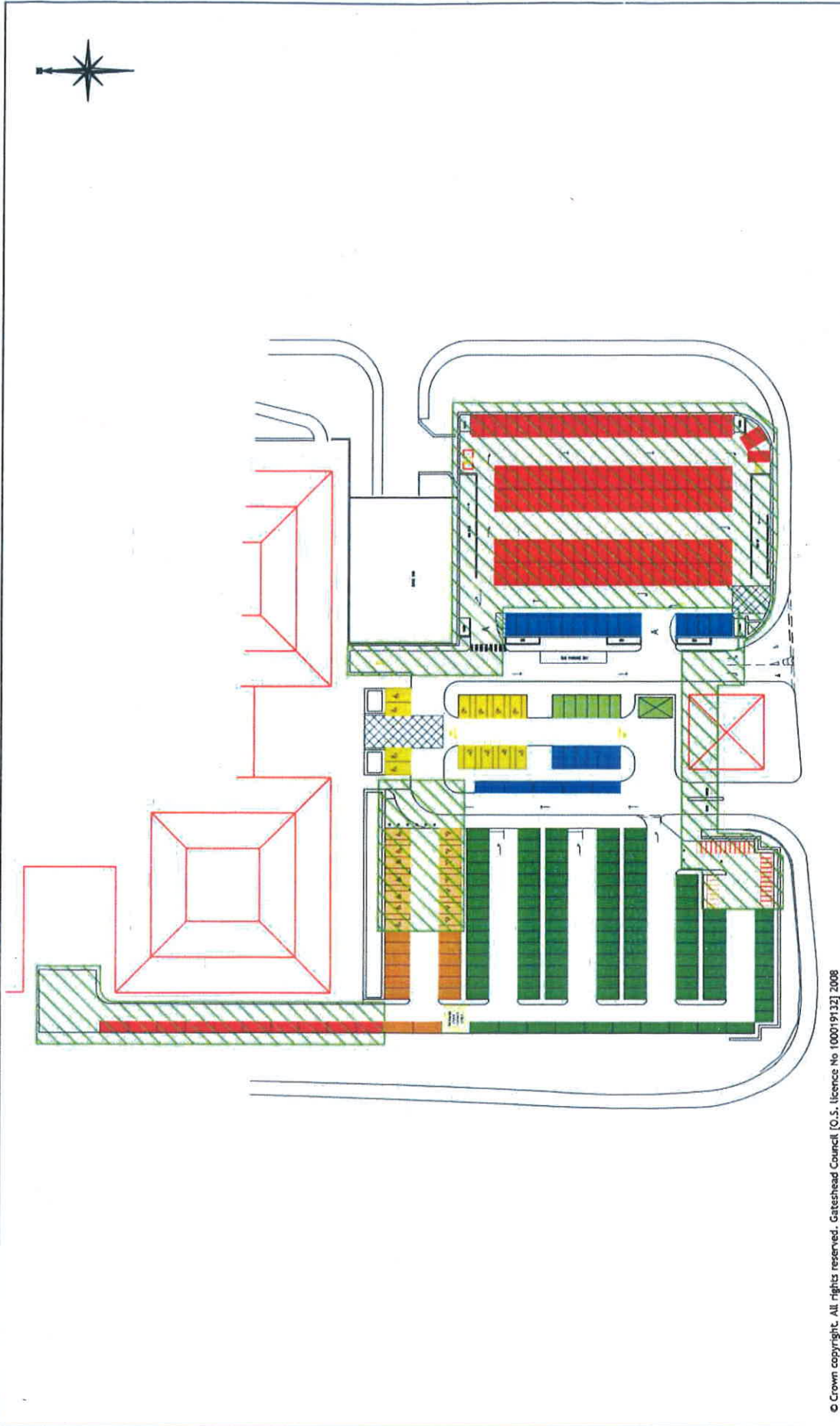

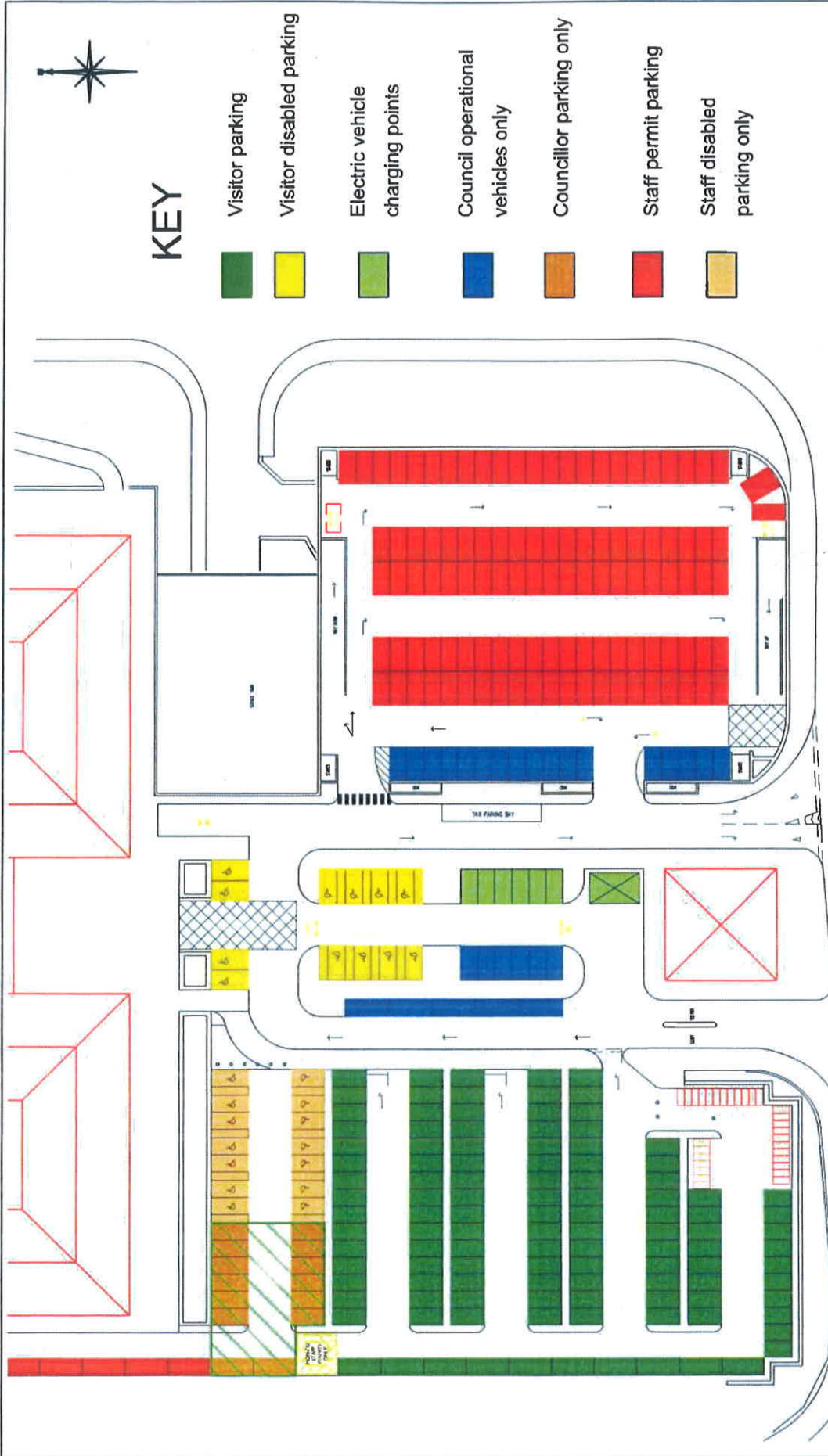
