THE BOROUGH COUNCIL OF GATESHEAD  
(WOODSIDE LANE RYTON)  
(WAITING RESTRICTIONS) ORDER 2005

NOTICE is hereby given that on the 6 June 2005, the Borough Council of Gateshead made an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the Order that comes into operation on the 13 June 2005 is to prohibit vehicles from waiting at any time on:-

- i. the west side of Woodside Lane from a point 72 metres west of its junction with Main Road in a south-west direction for a distance of 60 metres
- ii. the east side of Woodside Lane from a point 102 metres west of its junction with Main Road in a south-west direction for a distance of 28 metres

Normal exceptions will apply including those for disabled drivers.

A copy of the Order, which together with a plan and a statement of the Council's reasons for making the Order may be examined at the offices of the Strategic Director Legal and Corporate Services, Civic Centre, Regent Street, Gateshead, Monday to Thursday between 8.45am and 5.00pm and Friday 8.45am and 4.35pm (Ref.: TS 463).

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Act of 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 8 June 2005 apply to the High Court for this purpose.

**THE BOROUGH COUNCIL OF GATESHEAD

(NO WAITING AT ANY TIME) ORDER 2005**

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) to the Road Traffic Regulation Act 1984 ("the Act") and of all the other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Part I**

**General**

**Interpretation**

1 In this Order the following expressions have the meanings hereby respectively assigned to them: -

**"disabled person's badge"** has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000

**"disabled person's vehicle"** has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

**"disabled person's parking disc"** means a disc issued by a local authority (125 millimetres square) coloured blue if issued on or after 1<sup>st</sup> April 2000 or orange if issued before that date and is capable of showing the quarter hour period during which a period of waiting has begun: and -

**"relevant position"** means -

- (a) the disc is exhibited on the dashboard of fascia of the vehicle; or
- (b) in the case of a vehicle not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle;

so that the front of the disc is clearly legible from the outside of the vehicle.

A vehicle displays a parking disc in the relevant position if -

- (c) the disc is exhibited on the dashboard of fascia of the vehicle; or
- (d) in the case of a vehicle not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle;

**"universal service provider"** has the same meaning as in the Postal Services Act 2000

## Part II

### Prohibition of Waiting at Any Time

- 2 Save as provided in Articles 3 and 4 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait at any time in or on the section of Woodside Lane Ryton described in the Schedule to this Order
- 3 (1) Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to wait in the length of road referred to therein for so long as may be necessary to enable
- (a) the picking up and setting down of passengers;
  - (b) goods to be loaded onto or unloaded from the vehicle;
  - (c) the vehicle if it cannot conveniently be used for such purposes in any other road to be used in connection with any of the following operations, namely: -
    - (i) building or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance improvement or reconstruction of the said roads;
    - (iv) the laying erection alteration or maintenance in or in land adjacent to the said lengths of roads of any sewer, main pipe or apparatus for the supply of gas water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984;
  - (d) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority or water authority in pursuance of statutory duties;
  - (e) the vehicle to be used for the purpose of delivering or collecting postal packets in the service of a universal service provider
- (2) Nothing in Article 1 of this Order shall apply to any vehicle being used for Police, Fire Brigade or Ambulance purposes.
- (3) Nothing in Article 1 of this Order shall render it unlawful to cause or permit the following vehicles to wait: -
- (a) a hackney carriage (as defined in the Town Police Clauses Act 1847) waiting at a duly authorised cab rank;
  - (b) a vehicle waiting on a parking place duly authorised by an Order made under the Act provided that the vehicle is parked in accordance with the provisions of such an Order.

- 4 Nothing in Article 1 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position either a disabled person's badge or a disabled person's parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in the length of road referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day).
- 5 The restrictions and prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment
- 6 This Order shall come into operation on 13 June 2005 and may be cited as the Borough Council of Gateshead (Woodside Lane) (No Waiting at Any Time) Order 2005

- Woodside Lane Ryton** - i) on the west side from a point 72 metres west of its junction with Main Road in a south-west direction for a distance of 60 metres
- ii) on the east side from a point 102 metres west of its junction with Main Road in a south-west direction for a distance of 28 metres
