**THE BOROUGH COUNCIL OF GATESHEAD (ROWLANDS GILL AREA,
GATESHEAD) (SPEED LIMITS) TRAFFIC REGULATION ORDER 2019**

The Borough Council of Gateshead (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 82, 83, 84 of The Road Traffic Regulation Act 1984 (“the 1984 Act”) and Part IV of Schedule 9 to the 1984 Act and by virtue of the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

PART I

Amendments to The Borough Council of Gateshead (Speed Limits) (Consolidation) Order 2009

1. The Borough Council of Gateshead (Speed Limits) (Consolidation) Order 2009 is amended as follows:
2. In Schedule 2 Part II ‘20mph Speed Limit Zone’, revoke the Item relating to ‘South Sherburn’ in its entirety.
3. In Schedule 2 Part II ‘20mph Speed Limit Zone’ insert above the Item relating to ‘Salcombe Gardens Area’ the new Item for ‘Rowlands Gill Area’ below:

PART II

Contraventions

1. (1) If a vehicle is left in contravention of any Article of this Order a penalty charge shall be payable.

- (2) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice may then be issued by a civil enforcement officer or the Council in accordance with the requirements of Section 78 of the 2004 Act.

PART III

Savings and Commencement


1. (1) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act, or by or under any other enactment.
- (2) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the 1984 Act, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.
2. This Order shall come into operation on 8th day of April 2019 and may be cited as The Borough Council of Gateshead (Rowlands Gill Area, Gateshead) (Speed Limits) Traffic Regulation Order 2019.


